CALL TO ORDER

NEW BUSINESS

Ohly reported that the owner of Unit 16 (Otterness) has reported to him the continued water leakage problem in his unit whenever there is heavy rainfall. What can be done to prevent this recurring problem? Casey explained the drainage situation around Building Six. Will have to investigate further in the spring.

Tuohy proposed to increase the coin op machines to \$1.25 to wash a load of clothes and \$1.00 to dry a load of clothes. By valid motion, the increases were approved and will be implemented as soon as possible.

Tuohy also proposed to increase garage stall rent from \$35.00 to \$40.00 per month. After discussion, a motion was made and carried to increase garage stall rent to \$40.00 per month effective January 1, 2015.

Behrends suggested that owners be notified when there is an expense for the building of \$1,000 or more. Ohly stated he would notify owners by email or call directly.

NOMINATION & ELECTION OF NEW DIRECTOR

The term of Terry Jensen has expired and since Terry is no longer an owner in the building, cannot be re elected.

By motion, Derick Behrends was nominated and elected to a new 3-year term as a director.
