Terms and Conditions

1. Program Overview

- Ensure that the referred individual meets the solar requirements set by Rivers Edge Solar.
- Refer at least 10 individuals every quarter to maintain active status.

Please note that the partnership program does not allow individuals to receive additional compensation from other Rivers Edge Solar programs, such as the \$250 referral program and the legacy program.

3. Commission Threshold

To qualify for the \$1000 partnership referral compensation, the referred property must generate a minimum of \$3000 in commission for Rivers Edge Solar.

4. Notification and Updates

Once the referred individual has signed up through the Rivers Edge Solar website, we will keep you informed via email throughout the installation process. You will receive updates on the progress of the installation and activation of the solar panels.

5. Compensation

Upon completion of the installation and activation of the solar panels, Rivers Edge Solar will issue you a \$1000 compensation Visa gift card as a referral fee.

6. Program Duration and Termination

The Rivers Edge Solar Partnership Referral Program has an ongoing duration. However, Rivers Edge Solar reserves the right to terminate or modify the program at any time without prior notice. In the event of termination, any pending referral fees will be honored.

7. Limitation of Liability
