

## FOOD VENDOR APPLICATION

Thank you for wanting to be a part of the Rosthern Town and Country Fair! Please read the information carefully and answer the questions on this application. All applications will be given fair and equal consideration, but the Rosthern Ag Society reserves the right of final choice to avoid multiples of the same items. Thank you for your cooperation.

\*All applications will be reviewed in the order they are received. Full payment reserves your spot. If you choose to cancel your application for any reason, your fee will only be refunded up to June 30. After this date the full fee amount will be forfeited to the Rosthern Ag Society.

\*Electricity is 15 Amps and extremely limited on site. It is provided on a first paid, first served basis. If you require more than what we can adequately provide, you will be responsible for supplying and maintaining your own power. (i.e. a generator). Food trucks and large outdoor set ups are responsible for their own generators. Any generator deemed to be emitting in excess of 75 decibels may result in the vendor's eviction from event and forfeiture of all fees.

### WHAT WE OFFER:

- 10'x10' space with one 8' table or similar set up with your own tent, limited menu- \$175
- Small truck or trailer, larger menu- \$275
- Self contained, full size food truck with varied menu- \$550
- Located in the outdoor area directly outside the arena. If you do not require electricity, spaces may be available inside the arena upon special request or within the fair games area. Please let us know your preference, but final location decision is up to the Rosthern Ag Society.
- The Town and Country Fair sees approximately 1500 people over two days.
- Online, poster, and radio advertising in the weeks leading up to the fair, as well as announcements during the rodeo.
- Opportunity for sales all day Friday, Saturday, and Sunday July 23, 24 and 25, 2021.

### PLEASE NOTE:

- Set up times will vary depending on your desired days. Please communicate with coordinator.
- Foot traffic is not guaranteed.
- Fees for food vendors are discretionary depending on size of set up and what is offered. Communication is imperative and the Rosthern Ag Society reserves the right to decide which payment option applies. *You may only sell what has been previously outlined ahead of time in this agreement.*
