653 Deaths + 12,044 Other Injuries Reported Following COVID Vaccine, Latest CDC Data Show

The numbers reflect the latest data available as of Feb. 4 from the CDC's Vaccine Adverse Event Reporting System website. Of the 653 reported deaths, 602 were from the U.S. The average age of those who died was 77, the youngest was 23.

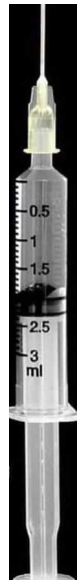
The MHRA monitors the safety of the vaccines as they are used on the public, and to this end they introduced a "Yellow Card Scheme" to collect reports of any suspected side effects. On February 11, an official report showed that a total of **59,614 suspected adverse reactions, were made regarding the Pfizer vaccine. 11,748 were made regarding the AstraZeneca vaccine**, which was rolled out only on January 4, 2021. The MHRA has received **143 UK reports of suspected ADRs to the Pfizer/BioNTech vaccine** in which **THE PATIENT DIED SHORTLY AFTER VACCINATION, 90 reports for the Oxford University/ Astra Zeneca vaccine** and 3 for unspecified brand. The majority were elderly people or people with underlying illness.
