**SELLER** guarantees that this dog is healthy and has had all recommended inoculations for its age at time of sale. **OWNER** agrees to house, maintain and care for this dog in such a manner as is healthy and proper for such an animal. **OWNER** agrees to continue the inoculation program according the advice of his veterinarian.

**OWNER** agrees to have dog examined by a licensed Veterinarian within 5 working days of receipt of dog. If at that time, any genetic problems or undetected diseases are found, **OWNER** may return the dog for a full refund or another puppy.

**OWNER** agrees to register the dog with AKC within the first 30 days of receipt of application for registration. Limited Registration is included in the purchase price.

If the dog develops a guaranteed problem at any time during the first year, contact us immediately—we will still hold to our refund or replacement policy. We will not refund your full purchase price and have you keep the dog. We will require a letter from your Veterinarian stating the health problem, or permission to speak with him/her about your dog. We will not pay any vet bills or any charges on any dog that we sell, neither will we be responsible for any shipping charges that may be involved in replacing a dog.

**SELLER** will not be responsible for any reactions that a dog may have to inoculations. Neither can we guarantee regarding loss of the dog because of accidental death, theft, sickness of any other loss beyond **SELLER'S** control.

**SELLER** guarantees the dog against hereditary diseases, which would prevent it from functioning for the purpose it, was purchased. We do not guarantee against skin or eye problems.

**OWNER** agrees that if anytime during the future it becomes necessary to give up the ownership of the dog, **SELLER** will be notified and will have the option of reclaiming dog at no cost to **SELLER**. **SELLER** agrees to keep the dog until the dog is placed in another home or be put to sleep as per breeder's discretion. This guarantee is void if ownership of dog has changed.

**OWNER** understands that the protection of this dog, in general, is the utmost importance to **SELLER**.
