A few people are willing to help run the electric. Tom can maybe get the wire, Mike can get a trencher. Researching aeration. Raised \$4382, about 23 \$100 donations, the \$1040 from tumbler sales.

Moved funds for gate, cameras and a new safe. We have an activities committee for 2024, Jill and Jeanette will be co-chairing with some other volunteers.

5. Old Business

- After removing several trees, John's Tree Service milled some of the lumber and brought us back \$500

6. New Business

- There will be a revised 2024 budget since the Masterson Schneider contract is still in review
- Received sewer plant rework bid of \$42K from Masterson Schneider must have recommended timeframe to consider for park assessment. Tank prices are increasing to \$200 for a \$1000 gallon tank and \$75 for a 350 gallon.
- Been in communication with the owner of the storage company next door, he will not impede our use of the driveway.
- Reviewing park insurance
- John's tree service has an interest in some forks that were from an old tractor or trackhoe in exchange for tree services.

John Ochs, Lot 229 asked the value, about \$300.

Eadie made motion to approve the trade of forks – Mike, Eadie, Tom and Marsha voted approve. Motion passed.

• Propose to sell the diesel tank and pump that we have no use for. Potential income is \$2500.

Mike made the motion to sell the diesel tank and. Pump, Marsha seconded. Eadie, Mike, Tom and Marsha voted yes. Motion passed.

7. Suggestions/Complaints – Eadie Schillinger

- Open Complaints -- None
- Open Suggestions 2 open suggestions: one for AED, Tom was unsuccessful getting one donated. Cost is about \$500 plus \$100 for wall cabinet. Will consider a fundraiser next year. The other is for a speed dip, is on the list to work in the spring.
