c. Environmental report - Tom Bauer

d. Lake report – Mike Miller

DNR inspected the dam, everything went well. Recommended some of the guardrails are coming loose and need to be refastened and keep vegetation outside of spillway around the PVC pipe. Mike reviewed what DNR inspected.

Big lake was successfully restocked on 10/31.

Live trapping has not been successful, will use firearms to control them.

Fundraising for lake aeration status earlier this past we raised \$3579. More donated this weekend.

At the end of the season, Jill is wrapping things up. Transferring funds from activities. \$3000 for cameras, \$1000 a new safe for the clubhouse, \$1000 for the gate fund. There will be an activities schedule for 2024 by March.

- Programmable thermostat for clubhouse; Mike bought one for the park and will be checked for comparability with our wiring and Marsha will get a 2nd one if it works without issue.
- Roll off has been removed until spring.
- Over the winter, will continue to look at options for barriers to prevent driving on the dams.
- Assessing how to handle lot owner water line repairs that impact park water system
