RESOLUTION POSTING WEIGHT RESTRICTIONS

WHEREAS, the Town Board is the road authority of Orrock Township.

WHEREAS, the Town Board works with limited road and bridge funds set by a levy set determined by the town electors at the annual town meeting.

WHEREAS, the road and bridge levy amount is to provide for year-round maintenance of township roads.

WHEREAS, the Town Board has determined that the paved roads in Orrock Township are typically constructed to 5-ton and 7-ton per axel standard.

WHEREAS, the Town Board has determined, after balancing various public policy considerations, that allowing vehicles of weight of 10-ton per axel on the Orrock Township roads, would impose an unreasonable burden on the Town's limited road maintenance funds.

WHEREAS, the Town Board has the authority pursuant to Minn. Stat. § 169.87 Subd. 1, to impose lower load limits upon certain town roads provided that the Town Board must first erect and maintain signs stating the load restrictions on town roads that are affected by the lower load limits.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of Orrock Township, Sherburne County, Minnesota that the roads or portions of roads identified on attached Exhibit A shall be posted as having a load limit of 5-tons and that all other Orrock Township roads shall be deemed and posted as having a load limit of 7-tons; and

BE IT FURTHER RESOLVED, that the appropriate signs shall be posted at the entry points to and at regular intervals, if necessary, as determined by the Town Board, along Township roads identifying their load limits.
