Communication Strategies for People with Hearing Loss

Presented by Judy Oetting, M.S., Speech Pathologist

Judy is one of our chapter founders. She has taught lip reading and other communication skills for 40 years and is one of our favorite presenters. Judy has spoken on a variety of topics. This month's presentation uses the hard-of-hearing communication strategies developed by psychologist Dr. Sam Trychin, who has a hearing loss himself. Judy has her B.S. degree from Northwestern University and her M.S. from Texas Christian University and serves our chapter as Librarian-Historian.

Chapter President Nominated for City Award



Chapter President Joyce Parlin was one of three finalists for the City of Fort Worth's Danny Scarth Trailblazer Award for her leadership in making Fort Worth more accessible for persons with disability. The award "recognizes a person who, in their everyday life, has raised awareness of living a life of value with a disability and made impactful changes in the Fort Worth community that improve life opportunities for persons disabilities.... Only volunteer activities are eligible for consideration."

The recognition was made during the Mayor's Community Engagement Workshops and Neighborhood Awards event on Saturday, March 2. The award is named for former city council member Danny Scarth (2006 - 2015) who used a wheelchair and was a strong advocate for students and adults with disabilities.

Fort Worth HLAA - How It all Began

As we mark the 34th anniversary of our chapter, it seems fitting to offer a brief account of our origins.

The first meeting of the group that became the Fort Worth Chapter of HLAA was held on Saturday, March 10, 1990, at the Goodrich Center for the Deaf and Hard of Hearing. Eighteen people attended, and they agreed to continue with monthly meetings and to seek affiliation with the national organization, then known as Self Help for Hard of Hearing People (SHHH).

Joan Lathrop, then executive director of the Goodrich Center, asked communications coordinator Dan White to start the group, since the Texas Rehabilitation Commission was urging the formation of SHHH chapters throughout the state. Dan partnered with Judy Oetting, who had earlier led hearing loss group sessions at the center, and with Marsha McClean, audiologist with Easter Seals. They combined their mailing lists and sent out invitations for the initial gathering.

In subsequent meetings, the group formed a steering committee to plan programs, conduct business, propose bylaws, and apply for a chapter charter from SHHH. The charter was received in March 1991, exactly one year after the first meeting. Clyde Black, Texas SHHH Coordinator and national board member, delivered the charter.

Self Help for Hard of Hearing People was founded by Howard E. (Rocky) Stone of Potomac, MD, in November 1979. In 2006 the national board voted to change the name to *Hearing Loss Association of America*. Our chapter has maintained membership since being chartered. We are now the only chapter in North Texas. Our vice-president, Kevin Medlin, has been charged with seeking to form new chapters in Texas.

February 10 Meeting Summary Area Agency on Aging Benefits Counseling Services

The Area Agency on Aging of Tarrant County (AAATC) is part of a network of 629 Area Agencies nationwide, one of 28 in the state of Texas, and the only one in Texas that is part of United Way. It exists to serve older adults, people with disabilities and their caregivers. It connects people with the resources they need to thrive - independently, if possible.

All Area Agency on Aging services are provided at no cost to those who need them. Benefits counselors around the state give presentations about the Area Agency on Aging.

AAATC, along with the Aging and Disability Resource Center (ADRC), assists with caregivers, utilities, housing, and transportation. Working with Texas Legal Services, AATC helps senior citizens for free with wills and related legal documents, including advance directives.

It can help navigate through the tough decisions people must make about health care options, answering questions about Medicare, Medicaid, prescription coverage, long-term care, and more.

As a Benefits Counselor with AAATC, Diana Vazquez-Spangler is certified by Medicare and by the State of Texas. Her work is to help people understand Medicare benefits with plan comparisons. She is paid by the State. Her personal mission is that people learn the information from the right source.

Medicare is medical insurance for individuals receiving Social Security benefits. If your card is lost, go to the local Social Security office, or call the national number for the Social Security Office, 1 (800) 772-1213. Medicare

only replaces a lost Medicare card three times. Don't laminate your card. Don't carry it with you. The doctor's office already has your information.

Medicare open enrollment is from October 15 through December 7. Consider Medicare drug coverage (Part D) when you are first eligible to avoid a late enrollment penalty.

Texas Medicare Savings Programs help people with limited incomes and resources pay for some or all of Medicare expenses and prescription drugs. Recipients must be entitled to Medicare (Part A). There are four Medicare Savings Programs:

- Qualified Medicare Beneficiary (QMB)
- Specified Low-Income Medicare Beneficiary (SLMB)
- Qualifying Individual Program (QI)
- Qualified Disabled and Working Individuals Program

The maximum income and resources for each level varies.

Everyone should have and peruse their *Medicare and You 2024* booklet. Texas has sixty-six Medicare Advantage Plans listed in the booklet. When comparing original Medicare or Medicare Advantage plans, request the number of a local agent. A local agent will come to your home if you ever have trouble with an explanation of benefits (EOB) or services.

Medicaid provides health coverage for low-income families, seniors, and people with disabilities. Medicaid is state specific. If a person moves to another state, they must re-apply. Because Medicare and Social Security are federal, they are transferrable from state to state.

Sixty billion dollars a year are lost by Medicare due to fraud. Check your Social Security and Medicare Evidence of Coverage statements for accuracy. AAATC can help with appeals. Senior Medicare Patrols assist Medicare beneficiaries to prevent, detect, and report health care fraud, errors, and abuse. Diana Vazquez-Spangler is the Tarrant County representative for the Senior Medicare Patrol (SMP). The SMP has a booklet called a tracker for recording doctor visits, date, and reason for the visit which the doctor signs.

Neither Medicare nor Social Security will ever phone people. Never give your Medicare or Social Security number over the phone. Know what HMO and PPO insurance benefits you already have so as not to be lured by a caller's promises. Imposters may try to keep you on the phone as long as possible while they sell your phone number to other scammers.

- Globally, more than 1 billion people (15% of the population) have some degree of hearing loss
- By 2050, this number is expected to double to 2.5 billion, according to the WHO
- One billion young adults are at risk of preventable hearing loss due to unsafe listening practices
- Hearing loss affects more than 50 million in the United States, or 1 in 7 Americans
- Many people with hearing loss are never tested or treated
