#### August 12 Meeting Summary

# Resources for Deaf and Hard of Hearing People

At the August 12 chapter meeting, Jennifer Clark, Manager of the Dallas Hearing Foundation, described the Foundation's mission and services and ran through a list of available resources. Jennifer has managed the Dallas Hearing Foundation for 12 years and has a college-age daughter with bi-lateral cochlear implants. Jennifer encouraged hard of hearing people to advocate for themselves.

Dallas Hearing Foundation is a needs-based nonprofit that works with children and adults with hearing loss in the greater Dallas area, across the U.S., and in nations around the world. DHF services include surgeries, audiological services and therapies, hearing aids and accessories, and cochlear implants. Surgeries are performed at the Dallas Ear Institute at Medical City. The surgeons and the anesthesiologists donate their services to Dallas Hearing Foundation patients.

The Dallas Hearing Foundation follows HUD low-income guidelines. However, income qualifications are flexible. DHF works with schools and with Medicaid to assure no kids "fall through the cracks." Since DHF stepped in, Plano police officers now receive up to 16 hours of deaf/hard of hearing training. One Plano 9-1-1 operator has hearing loss. Several operators know ASL.

The Dallas Hearing Foundation has a monthly meeting called the Lone Star Cochlear Clan where people considering cochlear implants mingle with people who have them. DHF also has a deaf teens group with deaf and hard of hearing adult mentors. The group discusses relationships and other topics. The teens learn to advocate for themselves. At Six Flags Over Texas, some of the teens received a Flash Pass, an \$80 dollar value for four people, as a perk.

DHF follows up with people who have come through their program to note their successes. November 4th is the Dallas Hearing Foundation's annual gala at the Dallas Hall on Dragon. Tickets are \$175.00. If money is an issue, Jennifer can sometimes get sponsors for people she thinks should attend.

The Dallas Ear Institute has a Fort Worth office at 3400 North Tarrant Parkway, Suite 120, Fort Worth 76177. Those approved for hearing aids can get them there. No surgeries are performed at the Fort Worth office yet.

#### JENNIFER'S RESOURCES LIST:

- The Dallas Hearing Foundation acts as a resource clearinghouse and directs people where to go.
- Texas Workforce Solutions provides free tuition to any state-funded college in Texas up to a Ph.D. for people with a certain level of hearing loss.
- STAP (Specialized Telecommunications Assistance Program) helps people with a disability that interferes with their access to telephone networks purchase specialized equipment or services.
- Texas House Bill 490 relates to health benefit plan coverage for children up to age 18 for hearing aids or cochlear implants.
- Starting September 1, 2023, if an infant fails the newborn screening, a CMV (cytomegalovirus) test is required.
- Early Childhood Intervention (ECI) is a Texas Health and Human Services program for families with children birth to age three with developmental delays, disabilities, or medical diagnoses that may impact development.
- AMC offers open caption movies. Open captions appear at the bottom of the screen. Search "AMC open caption movie times." Someone at the chapter meeting said that the cup holder closed captioning devices offered at some movie theaters are pretty much worthless. Another suggested holding it between the knees instead of placing it in the cup holder. If a movie theater is unaccommodating and you are afraid to advocate for yourself, text Jennifer Clark at DHF.
- Texas Hands and Voices is a parent-led non-profit assisting families with deaf or hard of hearing children.
- Childrens' Voice of North Texas in Denton aids families whose child has recently been diagnosed with hearing impairment.

- The Joyful Life Cochlear Implant Fund, headquartered in Colorado, helps the uninsured or underinsured to obtain cochlear implant parts or upgrades.
- With the SoundPrint smart phone app, users can measure sound levels and find restaurants and venues with quiet to moderate sound levels.
- Hard of hearing jurors may request a captioner rather than a court reporter.
- When staying at a hotel, request a Deaf and Hard of Hearing kit at the front desk. Kits usually contain telephone amplifiers and alerting devices for alarm clocks, door knocks, and telephones.
- Captioned phones like CapTel display captions of everything the caller says.
- Texas license plates with "I love you" in sign language are available at <u>myplates.com</u>. When registering or renewing your vehicle registration, present a completed Certification of a Communication Impediment form. Law enforcement will know you have a disability which may impede communication. In Texas, deaf or hard of hearing drivers can get a deaf or hard of hearing visor card to carry in their vehicle. - Texas apartment landlords, property managers, and property management companies are required to provide deaf/hard of hearing smoke detectors for their deaf/HOH renters.

Did you hear about our [HLAA national office] development team's wild 24-hour road trip to the HLAA 2023 Convention in June? ...It was worth the extra effort getting there. Workshops, social events, the Exhibit Hall and inspiring presentations gave us much-needed in-person rejuvenation.
