- **LOCATION** Near Woodson. Located just 15 miles south of Little Rock and 20 minutes from the Little Rock Airport. This property is accessible in all weather by Case Road, a paved county road, 35 miles from Stuttgart. In Sections 10, 11, 12, 13, 14, 23 and 24, Twp 2S, Range 11W.
- **DESCRIPTION** This tract, consisting of cropland enrolled in WRP and an adjoining 60-acre block of woods, is a premier deer and duck hunting property. The largest deer killed in Pulaski County, which scored 178 gross and is listed in *Boone and Crockett*, was harvested from this tract in 2010. Excellent duck hunting across the property is provided by natural flooding of low areas through rainfall, and it can be supplemented by 4 wells on the property. Wildlife food plots for both deer and waterfowl are maintained throughout the farm.

There are 2 sloughs that provide year round fishing along with private access to the Arkansas River for additional fishing opportunities. This property is adjacent to other large contiguous tracts of privately owned WRP, has been used exclusively for duck and deer hunting during the last 15 years and should only improve over time. This WRP tract was planted in 2003 and now has many trees over 20 feet tall and growing vigorously. There are 5 separate out parcels of various sizes located throughout the property for future development of club houses, lodges, etc.

SOILS Predominant cropland soil type is Norwood silty clay.

IMPROVEMENTS A large farm shop with utilities available provides excellent storage for hunting gear and equipment, and a workspace if desired.



Parcel Map









