## Citizen Participation

Speakers shall address the City Council with civility that is conducive to appropriate public discussion. Speakers can address only the City Council and not individual city officials or employees. The public cannot speak from the audience but only from the designated speaker location. This is an opportunity for citizens to comment upon city business and city business only.
