

Regular Meeting of the Bremond City Council

The regular meeting of the Bremond City Council was held in City Hall at 6:30pm Thursday August 15, 2019 with the following present: Mayor Swick; Councilmember's Boudreaux, Kujawa, Mikolajewski, Wilganowski, Burnett City Secretary Zan, Police Chief Pope and Denny Lessman.

1. Mayor Swick called the meeting to order at 6:33p.m.
 2. Pledge of Allegiance.
 3. Visitors- No one spoke during the allotted time.
 4. Councilmember Wilganowski made a motion to approve the July 18, 2019 Regular Council Meeting. Seconded by Councilmember Kujawa. Vote unan.
 5. Payment of Current Bills- Councilmember Boudreaux made a motion to approve payment of the City bills totaling \$30,527.84 dollars. Seconded by Councilmember Mikolajewski. Vote unan.
 6. Tax A/C Report- No report.
 7. Mayor's Monthly Report- Mayor Swick gave Council an update on the Texas Parks and Wildlife City Park Grant meeting, Texas Community Block Grant site visit, road work from milling of State Hwy 46 project for West Chamberlain Street and West Colorado Street renovations, Fast Grant for new Fire Truck and 150th City of Bremond Birthday Bash October 2019.
 8. Councilmember Burnett made a motion to approve Matthew Gorman to chip and seal two block near City Hall East Denton Street for \$12,100.00 dollars and apply a funding proposal with Type-A Corp. Seconded by Councilmember Mikolajewski. Vote unan.
 9. Councilmember Boudreaux made a motion to hire Mr. Lessman as City Prosecutor for the City of Bremond rate \$150.00 dollars hourly. Seconded by Councilmember Mikolajewski. Vote unan.

 17. Councilmember Wilganowski made a motion to propose a Tax Rate of \$0.52000/\$100 for Tax Rate 2019. Seconded by Councilmember Mikolajewski. Vote unan.
 18. Councilmember Wilganowski made a motion to approve City of Bremond applying for a Texas Parks & Wildlife Grant. Seconded by Councilmember Boudreaux. Vote unan.
 19. Councilmember Boudreaux made a motion to approve increasing the Trailer/Mobile Home Park Fees from \$200.00 dollars to \$300.00 dollars for each Trailer/Mobile Home and the one-time fee from \$1250.00 dollars to \$1500.00 dollars for the owner of a Trailer/Mobile Home Park. Seconded by Councilmember Kujawa. Vote unan.
 20. Councilmember Burnett made a motion to table Travel Trailer Park Ordinance. Seconded by Councilmember Mikolajewski. Vote unan.
 21. Councilmember Boudreaux made a motion to approve rewriting Ordinance No. 3-93 Seconded by Wilganowski. Vote 4-FOR- 1-AGAINST.
 22. Councilmember Burnett made a motion to approve putting oil sand on West Hunt Street to Hamburg 3 blocks and West Titus to Austin 2 blocks. Seconded by Councilmember Kujawa. Vote unan.
 23. Councilmember Boudreaux made a motion to approve West Chamberlain and West Colorado Street renovation. Seconded by Councilmember Mikolajewski. Vote unan.
