

Regular Meeting of the Bremond City Council

February 22, 2021

The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Monday February 22, 2021 with the following present: Mayor Swick: Councilmember's Mikolajewski, Boudreaux, Kujawa Wilganowski, Burnett, City Secretary Zan, Police Chief Pope, Kie Muzyka, Jackie Wilson and Tracey Hickman.

1. Mayor Swick called the meeting to order at 6:30p.m.
2. Pledge of Allegiance.
3. Visitors-Kie Muzyka thanked the council for serving.
4. Councilmember Mikolajewski made a motion to approve the minutes of the January 21, 2021 Regular City Council Meeting. Seconded by Councilmember Boudreaux. Vote Unan.
5. Payment of current bills- Councilmember Wilganowski made a motion to approve payment of the current City Bills totaling \$38,605.14. Seconded by Councilmember Burnett. Vote unan.
6. Tax A/C Report- Councilmember Mikolajewski made a motion to approve the Tax A/C report for December 2020 and January 2021. Seconded by Councilmember Kujawa. Vote unan.
7. Mayor Swick updated the Council on the City of Bremond's February 2021 Ice/Snowstorm. Mayor Swick spoke with Entergy Joel Threadgill and stated how helpful he was anytime we contacted him regarding the power outages. Atmos had an air bubble come through the line and caused some issues Sunday February 21, 2021. Centruy Link Mayor Swick stated he was not pleased with them because they do not ever do any maintenance on the line for tree limb, etc. City of Bremond was due to receive bottled water but was rerouted to Houston.
8. Councilmember Boudreaux made a motion to adopt a resolution to designate authorized signators for the 2020 Texas CDBG program contract 7220132. Seconded by Councilmember Mikolajewski. Vote unan.
9. Councilmember Wilganowski made a motion to approve a resolution adopting required CDBG Civil Rights policies. Seconded by Councilmember Kujawa. Vote unan.
10. Councilmember Wilganowski made a motion to Proclaim April as Fair Housing Month: This proclamation will help to fulfill Fair Housing activity obligations as required by the grant. Seconded by Councilmember Kujawa. Vote unan.

13. Court Clerk Report- Solley provided a written report.
14. Police Dept. Report-Chief Pope provided a written report and updated the Council on the hiring of a Police Officer.

15. Bremond Chamber of Commerce- Mayor Swick updated the Council Chamber of Commerce will not have Polish Day this year 2021 but possibly have a Bar-B-Que cook-off. Next Chamber of Commerce meeting February 23, 2021. Discussion only no action taken.
16. Fire Dept. Report- Firemen Kujawa stated the Fire Station was open 2 days as a warming station during the February 2021 Ice/Snowstorm. Fire Dept. received notice they approved for the 90-day extension on the new fire truck due to COVID. Fire Dept. responded to a house fire and were covering for the Marlin

Fire Dept. due to the City of Marlin have water issues. Bremond Fire Dept. will have their annual Crawfish Boil April 24, 2021. No action taken.
