

Regular Meeting of the Bremond City Council

February 22, 2024

The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Thursday February 22, 2024, with the following present: Mayor Swick: Councilmember's Mikolajewski, Kujawa, Wilganowski, Burnett, Boudreaux, City Secretary Zan, Robert Gadbois and Kie Muzyka.

1. Mayor Swick called the meeting to order at 6:30p.m.
2. Pledge of Allegiance.

Councilmember Boudreaux made a motion to approve PUBLIC NUISANCE SUMMARY ABATEMENT ORDINANCE AN ORDINANCE OF THE CITY OF BREMOND AUTHORIZING THE SUMMARY ABATEMENT OF CERTAIN PUBLIC NUISANCES; AUTHORIZING THE EXPENDITURE OF MUNICIPAL FUNDS TO ABATE CERTAIN PUBLIC NUISANCES. AUTHORIZING THE ASSESSMENT OF EXPENSES AGAINST OFFENDING PROPERTY THE PLACEMENT OF A LIEN UPON SAID PROPERTY, AND ESTABLISHING GENERAL PROCEDURAL REQUIREMENTS. Seconded by Councilmember Mikolajewski.
