

Regular Meeting of the Bremond City Council  
City of Bremond  
July 15, 2021

The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Thursday July 15, 2021, with the following present: Mayor Swick; Councilmember's Mikolajewski, Kujawa. Wilganowski, Boudreaux, City Secretary Zan, Police Chief Pope and Erica Gray.

1. Mayor Swick called the meeting to order at 6:30p.m.
2. Pledge of Allegiance.
3. Visitors- No one spoke during the allotted time.
4. Councilmember Boudreaux made a motion to approve the minutes of the June 17, 2021, Regular Council meeting. Seconded by Councilmember Kujawa. Vote unan.
5. Payment of current City Bills - Councilmember Wilganowski made a motion to approve payment of current city bills totaling \$553,859.29 dollars including the Robertson County Election bill original contract signed February 20, 2020, for \$9,597.50 dollars for the City of Bremond Election held November 3, 2020. Seconded by Councilmember Mikolajewski. Vote unan.
6. Tax A/C Report- Councilmember Mikolajewski made a motion to approve the April 2021 and June 2021 Tax A/C Report. Seconded by Councilmember Kujawa. Vote unan.
7. Mayor's Monthly Report- Mayor Swick gave Council update Matlock lease agreement City Attorney sent an email letter of discussion with new property owners. Dry Bean Saloon on Main Street owner will be tearing down due to structural issues City Council will revisit regarding the facia front of the building at the August 19, 2021, meeting. No action required.

10. Court Clerk Report- Court Clerk Solley provided a written report.
11. Police Dept. Report- Police Chief Pope presented a written report.
  - A. Councilmember Boudreaux made a motion to approve pay scale increase as presented by Police Chief Pope for Police Officer Cook/Part-Time Office Morris and new full-time officers hired. Police Officer Cook salary will increase to \$43,500.00 dollars yearly plus a \$1500.00 dollar Sergeant annually pay increase totaling \$45,000.00 dollars with Police Officers being entitled to cost of living raises during budget time. Seconded by Councilmember Mikolajewski. Vote unan.
12. Bremond Housing Authority- Erica Gray gave Council updates on the Bremond PHA. Discussion only.
13. Bremond Chamber of Commerce- Mayor Swick gave update on the Fall Festival in September 2021.Discussion only.
14. City Street Renovations/City Hall Parking Lot- Mayor Swick updated the Council on how many blocks there were in the City of Bremond and approximately there is \$120,000.00 dollars between the monies collected from the Street Fee, Type-A Corp., Type-A Street Fund, and COB general fund street fund. Oil cost approximately \$15,000.00 dollars a load and will do around 12 loads of oil sand. Discussion only.
15. Councilmember Wilganowski made a motion to approve the Authorization for the City of Bremond to issue requests for proposals (RFPs) for administrative services and requests for qualifications (RFQs) for professional services for the American Rescue Plan Act of 2021. Seconded by Councilmember Mikolajewski. Vote unan.
