

Regular Meeting of the Bremond City Council

The regular meeting of the Bremond City Council was held in the City Hall at 6:30pm, Thursday May 20, 2021, with the following present: Mayor Swick; Councilmember's Kujawa, Wilganowski, Boudreaux, Mikolajewski, Burnett, City Secretary Zan, Officer Cook, Kie Muzyka, Debbie Greensage, Alan Stilley and Koty Kuzinerak.

1. Mayor Swick called the meeting to order at 6:30p.m.

Load of oil will be \$15,000.00 dollars and will do 12 loads of sand. It takes 2 ½ loads of sand per block the cost will be approximately \$60,000.00 to \$75,000.00 dollars to possibly complete the streets. Councilmember Burnett made a motion to approve the purchase of the oil. Seconded by Councilmember Kujawa. Vote unan.
25. Councilmember Boudreaux made a motion to approve Robertson County Tax A/C to Calculate the Effective & Rollback Tax Rates for the 2021 Tax Roll. Seconded by Councilmember Kujawa. Vote unan.
26. Councilmember Boudreaux made a motion to approve the Homestead Exemption (\$5000 over 65 or disabled) for the 2021 Tax Roll. Seconded by Councilmember Mikolajewski. Vote unan.
27. Councilmember Boudreaux made a motion to table City Hall foundation stabilization. Seconded by Councilmember Mikolajewski. Vote unan.
