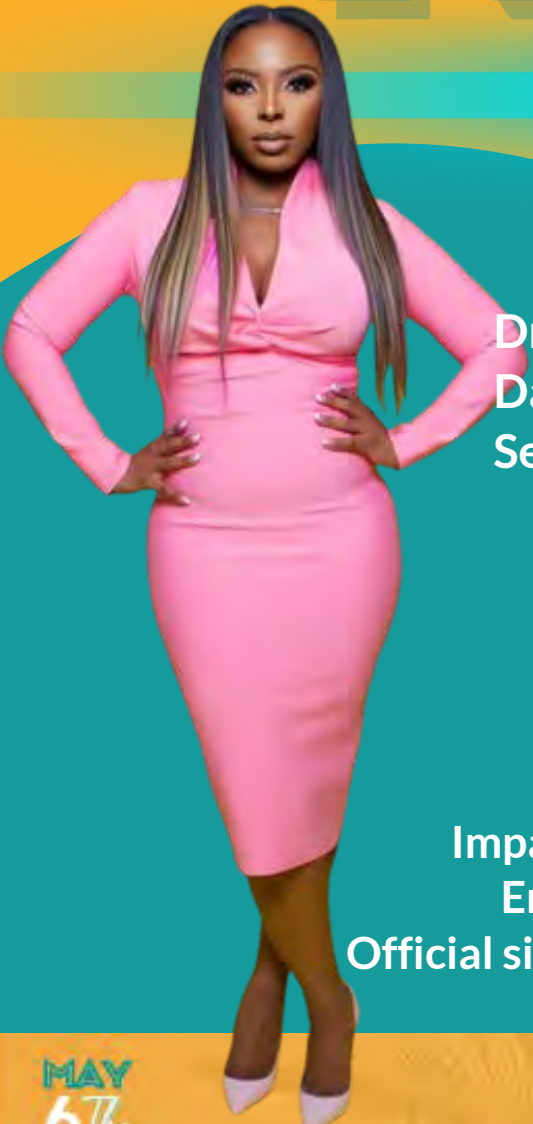

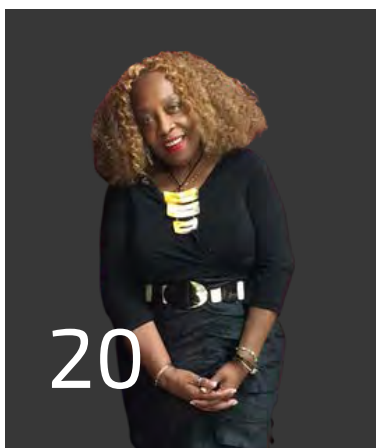

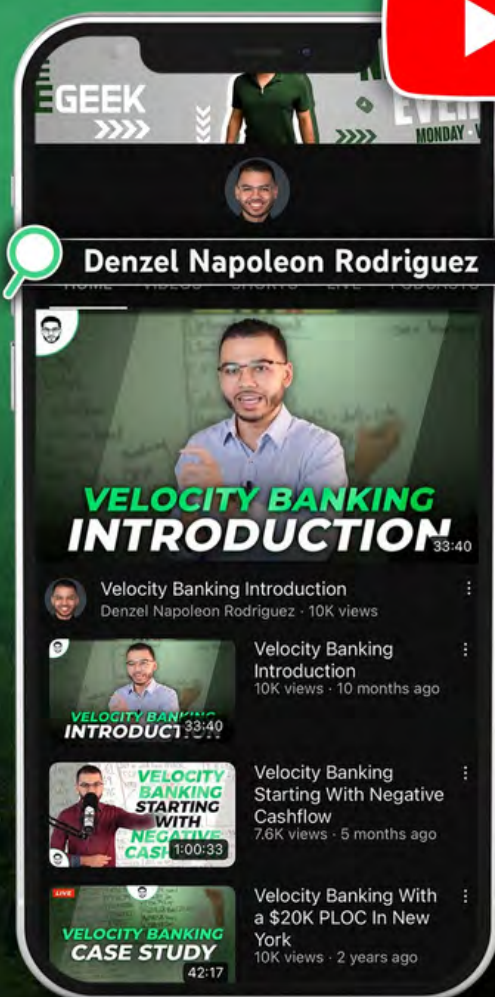

2022 GENERATIONAL CHAIN BREAKER

Dr. Jessica Clements was born and raised in a small town in South Georgia. Although she was raised in a nuclear family setting, limited income through her mother and father's jobs made life challenging. There were times when Jessica and her siblings ate, but her parents didn't. Despite the struggles, Jessica witnessed a lifestyle far removed from her own experience at school—other children having the luxury of a packed lunch or being dropped off to school in a nice car. This made her aspire for more than the one she grew up in. Jessica knew poverty would not be a part of the future she envisioned and so she started doing what she was told would take her closer to the lifestyle she desired—go to college and get a degree.

After attending college for a year, Jessica met her ex-husband, got married and moved from Georgia to Louisiana, where her husband was a pastor. They lived with his mother for several years as they struggled financially, trying to have a better life. She continued her studies, working towards a degree in finance and tried to figure out what the Lord wanted her to do. After a few years, they became involved in a financial opportunity that increased their income, but also led to sudden growth in their church and changes in her husband's behaviors. He became abusive, and she struggled with the decision of whether to stay or leave and based on how she understood scripture at the time, she had no real reason to leave. She felt God would have to provide her with a way out or she would stay because she loved her husband. The abuse continued until she finally left and moved to Texas with only her clothes in trash bags and her car. Jessica continued with her business and became very successful as a single woman. A short while after, she found out that her husband was living a double life, and she filed for divorce after five years of marriage.

After my divorce, I continued running my business and was successful as a single woman. I earned six figures, lived in a nice apartment, had two vehicles, and life was great. But things took a turn for the worse when I found out that my ex-husband was involved in illegal activities that implicated me as well. I had no choice but to turn myself in and was charged with 20 felonies, including racketeering and conspiracy, which carried a maximum sentence of 75 years in prison.

Fortunately, my lawyer knew the judge personally and I was able to get bail. I lost ever-

-ything during the four to five years of court appearances and had to move in with a friend from church. I graduated with a finance degree during this time but was unable to use it due to the legal issues hanging over my head. Despite working for minimum wage at Nordstrom's logistics department, I managed to rebuild my life.

One day, I received a message from God telling me to apply to a particular bank. Though I was hesitant, I applied and eventually got a job as an underwriter. I then received another message from God telling me to buy a house and a car. Just as I was getting used to my new life, I had to go back to court to be sentenced. Though 90 of the charges were dropped, I still had to take one charge, which meant I would be on probation and had to pay restitution of approximately 40 percent of the total loss to the individuals, allegedly 3 million dollars.

After overcoming this challenging experience, I found myself in a difficult financial situation. Fortunately, I had a stable job with good benefits and a supportive work environment. Despite this, I knew my boss would never pay me enough to live the lifestyle I desired. As a result, I began considering alternative options.

This is what led me to discover day trading. Although it took me some time to learn the ropes, I was ecstatic when I made \$43,000 in just one month. This breakthrough gave me the confidence to leave my job that same year, and I have since been enjoying the freedom to live life on my own terms. In 2021, I even reached the seven-figure mark, which completely changed the trajectory of my life. I now use my experience to teach others who have also achieved financial success.

Looking back, I realize that my current success is largely due to my decision to trust in God during a challenging season when everything seemed to be going wrong.

WHAT IS DAY TRADING?

Day trading involves the exchange of commodities such as gold, silver, oranges, or any tradable item. It's similar to going to a supermarket and using money to purchase a product with the expectation that its price will either increase or decrease. Essentially, day trading is the exchange of a valuable item for another.



CHALLENGES OF BEING A SELF-MADE MILLIONAIRE.

Initially, reaching the seven-figure mark in this business posed psychological challenges for me, as it does for many others. Suddenly, I was making seven figures in just hours after being accustomed to five figures per day. I was faced with the dilemma of what to do with all this money. Should I spend it on assets such as real estate or indulge in personal luxuries like a new car or Chanel purse? Despite the desire to acquire everything I had always wanted, I realized that I had to exercise self-control and prioritize legacy-building over immediate gratification.

Another challenge was learning how to save money and invest in long-term assets like real estate to secure my financial future beyond trading. Additionally, I recognized the importance of creating multiple streams of income, including my school, real estate portfolio, and mentorship services.

Upon hitting the six-figure mark, I knew that to reach a million, I needed to make significant changes in my life to facilitate growth. This led to the complete reorganization of my home, creating designated spaces for various activities like working, relaxing, and eating. By eliminating distractions and focusing my mind on the task at hand, I was able to tap into my creativity and generate ideas needed to make money, ultimately leading to my achievement of the seven-figure mark.

HER INFLUENCES AND THE IMPORTANCE OF HAVING A SUPPORT SYSTEM.

Initially, I didn't have any role models to look up to. However, in 2008, I connected with a lady who is now my business coach. At that time, she struggled financially and was involved in multilevel marketing, but I couldn't afford to join her business. Over time, I watched her go from being poor to becoming a millionaire with a family to take care of. She's known as The Millionaire Mom, and I consider her as one of my influencers. I observed her achieve the time freedom that I yearned for and still maintain humility and trust in God.

I admire her for not forgetting that God is the ultimate source of everything, including wealth. Even when people start making money, they tend to forget their source and can lose everything. Therefore, I look up to her example and keep trusting God as my source, especially because I need him to keep blessing me.

I believe in trusting God in every aspect of my life, not only when I need financial help. People who say they trust God only when they need financial assistance lose their trust when their needs are met. So, I trust God more now than before, even when I had no money.

THOUGHTS ON BEING IN A MALE-DOMINATED SPACE

Because the day trading industry is predominantly male, women have a unique advantage to excel and achieve success. Studies have shown that men struggle with managing money in day trading due to their impulsive and risky nature. Women, on the other hand, approach trading more strategically, with a calculated approach to risk management. Unlike men who adopt a gambling mentality, women are more likely to jump in and out of trades and manage their time effectively without the need to trade all day. Personally, I did not leave my job to day trade full-time. Many of my female friends who trade are making millions and living extravagant lifestyles, but they remain humble and focus on expanding their wealth through wise investments. Rather than boasting about their profits, they are always seeking new opportunities to grow their money.

ON HOW WOMEN SHOW UP TODAY, WHAT ARE WE DOING RIGHT AND WHAT IS IT THAT WE NEED TO DO BETTER?

I believe that women today are bolder and more well-rounded compared to 50 years ago. They are capable of balancing their domestic duties, such as cooking and raising children while running multimillion-dollar businesses and attending black-tie events. As women evolve and grow, they have become better-calculated risk-takers, which makes them valuable assets in leadership positions. In fact, some companies function better with women in higher positions because of their ability to think through risks.

However, we need to improve how we present ourselves in relationships. While being strong is admirable, we need to understand when to show our delicate and feminine side. It's important to maintain our femininity because it can lead to more opportunities and open doors for companionship. When we show up as strong and independent, we may inadvertently push people away, including men who might be intimidated by us.

WHAT IS YOUR LIFE MOTTO? WHAT GUIDES YOUR LIFE?

One of my life mottos is YOLO, or "you only live once." I embrace this philosophy by fearlessly pursuing my desires and making the most of my life. However, I also value treating others with kindness and respect, as I believe in the power of giving and receiving. This is another motto that I live by, and I strive to embody this principle in all aspects of my life.

I believe that being a great leader involves not only leading but also being a good follower. As a leader, I strive to understand where my team needs to go and I guide them through example, not just by managing them. Leading is about demonstrating how to do things and inspiring others to follow in your footsteps.

It is important to have people in our lives who can guide us toward our goals. A good follower also recognizes that submission is a key component of growth in both business and life. 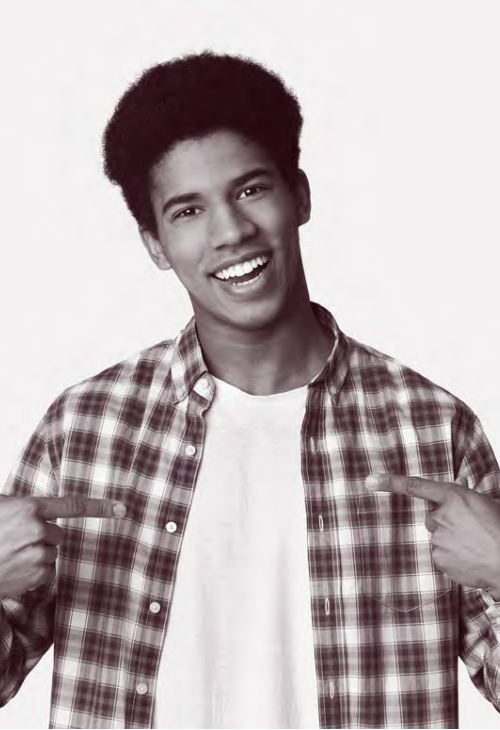

ALEXANDER STAR

Spreading Love and Positive Messaging Through Music

Our conversation with Alexander Star was inspirational, as he shared his love and joy for music and how he uses it as a tool for empowerment, particularly for disadvantaged children. He is not concerned with conforming to popular trends or creating music that appeals to the masses. Instead, he believes that whatever he creates, must have a deeper and far-reaching impact, touching the core of humanity and enabling others to rise above any negative experiences they may be facing. This is exemplified by his charity work with children in foster care.

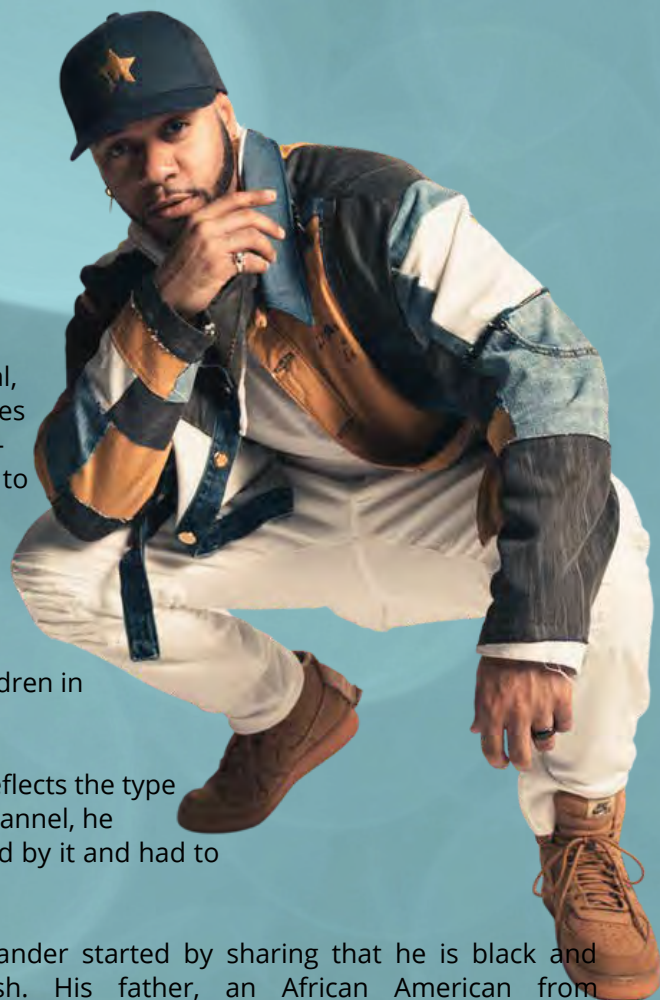
His latest song, "Just One Firefly" (211 Anthem), also reflects the type of work that Alexander focuses on. On his YouTube channel, he shared the story behind the song, and we were moved by it and had to share it here:

In 2022, an awesome woman named Tracy Schuldiner came to me with a humble request: to write an anthem for 211 Broward. 211 is a national phone service connecting real people with crisis support and community resources. I like to describe 211 this way: When you're in a physical crisis, you dial 911, but when you're in a mental crisis, you need to dial 211. There's someone on the other end trained to listen and connect you with resources to heal your situation. Honestly, not enough people know about 211 so I wrote "Just One Firefly" from the perspective of someone who needs them but doesn't know they exist. When brainstorming concepts to write about, I referenced vivid memories of fireflies lighting up the field in my backyard as a kid growing up in small-town Tennessee...Their presence made the pitch-black night seem a lot less scary. To take it a lil' deeper... Many of us find ourselves trapped in dark situations that we can't seem to find our way out of. It gets so dark that we have trouble seeing or even imagining the exit. But here's what fascinates me: No matter how dark the room...even the tiniest speck of light can cut through the shadows and illuminate the way out. This is the inspiration for "Just One Firefly," the official anthem for not only 211 Broward but now the entire national 211 Helpline. When this world gets dim and the shadows close in on you...211 can be the firefly that helps light your path home.

During the interview with Alexander Star, we were intrigued to learn more about his background and how he developed his passion for music.

Alexander started by sharing that he is black and Jewish. His father, an African American from Fayetteville, North Carolina, and his mother, an Ashkenazi Jewish hippie from New York City, met in Albuquerque, New Mexico, got married, and had his sister. They then moved to Pennsylvania, where Alexander was born. When he was two years old, they moved to Tennessee, where he was raised until the age of 14. They then moved to Greensboro, North Carolina, where he spent his 10th-grade year. The day before his 11th grade, he moved to Florida, where he has been ever since.

Alexander's father is an award-winning concert pianist and a classical musician. He won at a high level as a black man in a white man's world throughout the civil rights era and beyond. Alexander grew up with a classical piano in the living room, but he wasn't disciplined enough to let his father teach him how to play. Instead, Alexander's gifts manifested in language, and he developed a passion for communication through words.



Q. Okay, could you please elaborate on your gifts being manifested in language, what do you mean by that? Did you start writing songs?

A: Yeah, as a kid, probably for the first time, I heard rap music and started writing rhymes. I grew up in a small town in Tennessee in the early 90s, writing raps in class, for school projects, and for show-and-tell. I always liked rhyming and I'm an English nerd; I was a straight-A student my whole life. Words have always been my thing. And what I realized very early on is that when you put words together a certain way, people react. So, I remember rapping in the gym class or cafeteria in middle school, finding ways to say things that would make people react, laugh, yell, or evoke any other kind of emotion. I realized early on that I could use language, messaging, storytelling, and imagery to impact people.

As a kid, it was for having fun, clowning around, and getting girls' attention. But as an adult, I began to realize how impactful I could be when I used my language and artistic gifts creatively and positively. I used to battle rap, but then I realized that if I continued, I would be stuck in that space and not see any growth or longevity. So, I had to change my crowd.

Having the right influences helped me a lot. I had mentors and older friends that I called brothers. We were in a recording group called Free Agents in the 11th grade, and we manufactured our own albums. We would sing acapella in the streets and sell our CDs. This was all before the social media era, and we sold thousands of CDs. That's where I got a lot of my performance experience, and I have a lot of great memories and times from that group. Unfortunately, the oldest member of the group passed away at age 31 from diabetes complications, and the group lasted roughly five years.

As an individual artist, I found my place by using music for impact. I have experienced the music industry, and I know what it's about. A lot of it is not authentic, and that is not what I like about the music industry. Remaining authentic to myself means that I had to forge my own lane and build my own path, and that is what I'm doing as an impact artist.

Q: Generally speaking, the world does not gravitate towards positive music. Artists who create positive music don't get as much visibility. How do you remain relevant and stay true to yourself?

A: Well, that's actually a great point. It's something that I had to learn over time. When you have a positive message in music and you're outright blatant about it, people automatically don't want to listen because they presume you to be corny or like bubble gum or whatever. I get around it by being 'dope' minus ignorance. You can be 'dope' without pushing an ignorant message, and people need that proven to them. I prove that daily. So, it's just a matter of having standards and integrity. Most artists are more concerned with counterfeiting what they perceive as success rather than creating something authentic to who they are. Most artists feel they have to write about having things, they feel like they have to appeal to the masses even if the message is misleading.

Q: But that is how they get paid.

A: No, that's not how they get paid. That's how the machines who have the money to market artists who portray those lifestyles get paid, not the artist. And those machines control the airwaves, from the Spotify playlists to the YouTube videos that you see, social media, everything is bought and paid for, except for a few organic cut-throughs, but they're rare. Everyone feels like because this is what they see on a mass platform, that's what they have to be like to be successful. But I'm the artist that's proving that to be completely wrong by winning in my own lane.

Your fingerprint is what makes you, you, so why look at other people's fingerprints? And it's not even their fingerprints, it is a fingerprint designed by their benefactors—the person putting money behind them and telling them what to do and what to talk about. Why does the black culture make music glorifying self-hatred, glorifying killing ourselves, and glorifying dogging our women? Why are we the ones denigrating our own people and culture? It's backward, but it's because many of the people that we see that have huge platforms are bought and paid for. So, those of us who aren't bought and paid for, we're against the grain, by nature of the industry. But the idea of being an impact artist is proving to the world and proving to other up-and-coming artists, and even other established artists, that simply being the best version of yourself is what we must push. It should not be about material possessions. I would rather you tell me that you live in an apartment and the fan is broken and you're missing blinds on the windows, or your rent is too high and the hot water is off and rap or cleverly sing about that, than to hear you tell me that you're in the four seasons with two models—I'm like, no, you're not.



Q: What informs your music? What are the influences that you see in the world that you want to share, specifically in your music?

A: I pay close attention to the world around me, including both frivolous and important issues that affect people. Social and environmental matters are also important to me. I diagnose the things that I observe daily and then write musical prescriptions based on what I see. I am constantly analyzing and having conversations with myself about what I see, and inspiration strikes when the topic comes to me. I include bullet points and then I write.

When it comes to my songwriting, I set a very high bar for myself. I approach it as a conversation as if I am talking to someone. If they seem bored, then it means that what I am saying is not interesting. This is how I approach my songwriting. Once it is interesting to me, I continue until I find something that makes me go "woe!" If that feeling is missing, then it's not even worth writing down.

Q: Your music has a positive message with impact. Can you share an experience where your music directly caused change at the community or government level?

A: I have had many experiences with impact through my music. I've spent nearly a decade, visiting teens in foster care and helping them write and record original music around their lives. One of the most significant ones was during my time when with the SIPPS program—Statewide Inpatient Psychiatric program. I was commissioned to lead the Lyrical Expression program within it by way of a Miami non-profit called The Motivational Edge. This program was for High School kids who had experienced trauma ranging from human trafficking to drug abuse and were unable to attend regular school due to the severity of their situations. Every weekend for about three or four years straight, I would go into this lockdown psychiatric facility to spend an hour and a half on lyrical expression with each set of boys and girls. During that time, I set the standards for these kids and let them know that we would record music that did not contain expletives and that we wouldn't glorify ignorance. Instead, we would write about what they were going through and experiencing.

I have received written and signed letters from psychiatrists and school psychologists saying that since I started visiting with the kids, there was a transformation in their behavior. These were kids who had been battered and abused, and one of the reasons for the transformation was that they didn't want to lose the opportunity to record with Alexander Star on the weekends.

One of the most memorable experiences I had was working with a 14-year-old boy who had been molested by his father for his entire life. One day, he snapped and stabbed his father to death. At the time, he may have even been 13 years old. I remember thinking that you never know what someone is going through until they open up and let you in. They have all the reasons in the world not to trust adults, so I showed up as a friend, not just as an adult ready to tell them what to do. I helped them to see beyond their current challenges, and together we created music based on their experiences. This particular 14-year-old was eventually acquitted, and I remember him coming to me and sharing emphatically that he was not guilty. It was triumphant to see him get another chance and the courts giving him another chance by understanding his situation.

Working with these kids solidified my path as an impact artist because I felt obligated to show them that they could be themselves and not follow the path of everyone else. Many of these kids came from situations where there was a lack of good parenting, and they were literally raised by a radio. I remember having a conversation with them where I asked what they would do if they received \$10,000. Their responses were unrealistic, and it made me realize that their idea of how the world works were shaped by the music they listened to. The way our culture is shaped around art, particularly music, literally raises our kids. I want the impact of my powerful art to empower people, not bamboozle them and empower the system instead.

Q: What is one deficit you've observed in how men operate today, particularly concerning their children, and how can they improve?

A: This is a thought-provoking question. One deficit that comes to mind is the lack of mentorship and willingness to share the recipe for success. Many men achieve success but are reluctant to disclose how they achieved this success. The unwilling attitude stems from a fear that others will take what they have, which can hinder the growth and development of aspiring individuals. However, I firmly believe there are enough opportunities for everyone to succeed when they operate according to their DNA. By sharing our strategies, we enable others to apply their unique strengths and qualities to their approach. The fear of losing what is ours should not prevent us from helping others.

To address this deficit, men can lead by example and actively mentor those around them. It is cruc-

A: That's an excellent question, but I have no idea.

Q: Okay, what is one word you would use to describe yourself?

A: Um, I have to be really particular with this answer. I guess "particular" is a good word. I am very particular with everything - the way I dress, how I speak, and what I invest my energy, thoughts, and time into. Yes, being particular is a defining trait of mine.

Q: Share a life motto or a quote that has guided you through life?

A: I don't necessarily have any specific mantras to quote, but I would like to share a lyric from one of my songs that resonates with how I approach the world. As a young man with a multi-racial background and diverse religious experiences, my parents never forced religion on me, so I was raised to live with love, believe in my heart, follow my gut instincts, and be a good person. The opening line of my song "Sticky Situation" is, "Love is my religion, I got no denomination," which means I want to positively impact the world. Bob Marley also had a song called "Love is my religion," which represents the impact I want to make. Bob Marley's music brings peace, hope, relaxation, and love wherever it is played, and that is how I want to live my life. No matter where you come from or how you were socialized, I want to have a conversation with you, find common ground, and relate to you. I don't have the kind of discrimination that is prevalent in the world, within me.

Q: What has been your biggest highlight professionally so far?

A: It is difficult to single out one particular highlight because each experience is different and deserves recognition. For example, helping kids who've suffered unspeakable traumas make music is just as important as having my song featured in a Superbowl commercial. If I were to receive a Grammy, it would be just as significant as having my song "Just One Firefly" (211 Anthem), saving a life because it created the awareness within them that if they are in trouble, they simply need to dial 211. Both are deserving of recognition because they impact the world positively in different ways. My goal is to recognize and highlight them all so that others can see that they don't have to create degrading content to win, but they can also use their talents to spread positive messages and make a positive impact in the world.

Q: Lastly, can you give some general words of encouragement to wrap up this amazing exchange?

A: My advice to everyone is to recognize that you were born with the gifts you need to succeed in life. Be self-confident and utilize those gifts to their fullest potential. If your gift is knitting socks, then knit the best socks you can, and find a way to get people to wear them. Don't let anyone discourage you by telling you that nobody wants knitted socks. I've had gatekeepers, label executives, and others tell me that I need to create music about strip clubs to succeed in life. However, I rejected all of that and still achieved success without compromising my values. If you know what you're doing, love what you're doing, and have a purpose within it, then go for the win in that area. Hold onto that thing because God will deliver every opportunity you need to utilize your gifts and succeed. Just pick up the ball and run with it, knowing that people will come at you, but you will have blockers you didn't even know you had, and you will keep running!
