## **VP Racing- Kim Bull**

I will start by confirming that I will not be leaving the Club despite the "Incident" that was listed in last month's minutes. I left the meeting, as I felt disrespected whilst performing one of my many elected roles as an APBA Volunteer and VOC Club Official. I attend approximately 40 National, State, Club and International meetings a year, some in person and some via zoom so I can perform my elected roles to the best of my ability. I try and keep abreast of what is happening at all International, National, State and Club levels and report back with facts rather than the rubbish you often read on social media. After the "incident" a written apology was forthcoming so let's continue to move forward for the good of the sport. Something I will always try and do.

This year I will not be standing as Race Secretary, VP of Racing or Secretary. In the past few years Andrew and I have worked together in these roles to ensure that all the VOC run event planning was completed. These roles, along with the very important Secretary role need to be done correctly, and need to be actively completed otherwise no events can proceed. I believe it is time new faces stepped up and took on some of the responsibility to drive the Club forward. I will continue to offer my assistance and past correspondence to anyone wishing to step up to take on these roles. #### Please read and consider my report from last year.

In the role of the Race Secretary, the job starts months before the event with the permit applications needing to be submitted at least 10 weeks prior to race date. Whilst this process should be relatively simple as we have raced for many years at our usual race venues it is an ever-changing process.

After the permit approval I have generally handed the event notes / competitor guide preparation to Andrew as this is his forte.

Once these have been distributed, generally after some coercion, the entries start to arrive. Usually, somewhat incomplete and need to be reviewed manually and any omissions highlighted so they can be rectified on race day.

Then the entry packs are prepared with the indemnity forms (these Indemnity Forms are no longer required as we have the sign in books, however a laminated copy of the Indemnity forms must be with the sign in books for everyone to read), the wrist bands and the scrutineering forms. Once prepared they are labeled, and lists prepared for checking on race day.

Then race day comes and an invasion starts for paperwork, payments and hopefully, the successful return of all completed paperwork. Once this stage is completed and again checked off the race day can start.

Hopefully the day can be completed without incident, so no additional paperwork and then all the race day stuff is transported home for another round of checking and cross checking.

If all went well everything will be in order. If not, then there are the follow ups to drivers to get it right.

Then when it's all completed its all filed away and the next event rolls around.

If this sounds like fun, please step up and have a crack as the new VOC race secretary. If not please ensure that in the future all entry paperwork, scrutineering form and prompt payments are received.
