Thank you for booking your session at Kandi Kane Christmas Tree Farm! We appreciate your business and look forward to working with you and your clients. Please read over all information in this document and return a signed copy. A signed copy is required for you, your clients and anyone else that may be entering Kandi Kane Christmas Tree Farm for your session(s). Signed copies must be returned to Kandi Kane Christmas Tree Farm before your scheduled session(s). We will have copies on hand at the farm.

I, my employees, my clients and any other person(s) entering Kandi Kane Christmas Tree Farm agree(s) that they have read and understand the document made available on our Kandi Kane Christmas Tree Photography webpage:

Including the following excerpt:

WARNING

"Under Tennessee law, there is no liability for an injury to or death of a participant in an agritourism activity conducted at this agritourism location or by this agritourism professional if such injury or death results from the inherent risks of the agritourism activity. Inherent risks of agritourism activities include, among others, risks of injury inherent to land, equipment, and animals, as well as the potential for you to act in a negligent manner that may contribute to your injury or death. You are assuming the risk of participating in this agritourism activity."

I, my employees, my clients and any other person(s) entering Kandi Kane Christmas Tree Farm also understands and agrees with the following guidelines:

- We are a new Christmas Tree Farm and have 7 year old Blue Spruce trees that range from babies to around 8' tall. All other varieties of trees on our farm are still small averaging around 3-4 ft in height.
- Sessions are \$50 per hour. Minimal of 1 hour and we do not prorate time.
- 50% non-refundable deposit is required when the session(s) are booked. The remaining balance is due one week before the appointment date; you will receive a reminder for the balance. If you book 7 days or less before your appointment, then 100% is due at booking.
- No refunds are granted, so please book session with that in mind.
- Sessions must begin and end at booked time. Please schedule enough time for your session. There may be other photographers and clients preparing for the next time slot available. Be courteous to others. Consider that begin time is when you plan to arrive at the farm (not when your client sessions start), and end time is when you plan to leave the farm (not when your client sessions end) including setting up and removing all props. You may come early and meet in the parking area before your session(s) begin.
- Appointments cannot be changed based on weather forecast.
- The weather rescheduling policy only applies if rain is occurring on the farm at least one hour before your session time, not necessarily raining where you or your clients live. You will be allowed to rebook your session based on available dates for this season. Due to limited amounts of weekends, you may be required to book weekday sessions. Deposits are non-refundable.

- Pets are welcome; they must be leashed and always picked up after. Please be courteous to others and help keep our farm clean.
- **DO NOT** park or drive in the fields; everyone must park in the designated parking area. **Vehicles are NOT** allowed in Christmas tree fields under any circumstances. All props, furniture, etc. must be carried to your photoshoot location. We recommend bringing a wagon to transport props and other items. **Please park in the designated area**.
- Please keep our farm clean by not using fake snow, glitter, confetti, or any other substance on our trees or ground that can't be cleaned up completely because they do not disintegrate. Please pick up any trash or debris in your area. A trash can will be available near the gift shop.
- Farms are dangerous places. Please be aware of dips, holes, stumps, insects, poison ivy, briars, fallen limbs, tall grasses, wood piles, bees, etc. There are holes and ruts in the fields--please use caution.
- We work on the farm year-round. Tractors, mowers and other equipment might be in use. October and November are especially busy months as we prepare for our tree selling business. During that time, we will be setting up, moving equipment, cleaning, etc. Please stay outside of the boundaries of any yellow caution tape.
- **DO NOT** let anyone go barefoot. Farms are dangerous and should never be visited without shoes.
- Ask your clients if anyone coming to the shoot is allergic to bee stings, or any other insect; if so, clients must be prepared by bringing the appropriate antidote. We cannot give out antihistamines or EpiPen's.
- We do not have restrooms. So be prepared.
- Please do not venture onto our neighbor's property. Farm boundaries will be flagged. Please be respectful of our neighbor's private property.
- **DO NOT** move any items we have on site without prior permission. You are welcome to use any item on the farm in the immediate tree area as a backdrop, but please do not move the item.
- **DO NOT** go inside the stable. There are items inside that could be deemed as dangerous.
- **NO SMOKING** or **VAPING.** Smoking is **NOT** allowed on our farm. This can pose a risk of fire that could destroy our entire farm. It is also not respectful to those that do not wish to be in the presence of smoke including vapors from vaping.
- Open or closed flames of any type, fireworks, sparklers or any other items that may cause a risk of fire are **NOT allowed**. If you have an idea, please ask for our approval. Our farm is our home and our business.

I have read and understand the guidelines and consent to following them completely and understand that I, my employees, my clients and any other person(s) entering Kandi Kane Christmas Tree Farm must abide by these guidelines.
