#### b. Trick or Treat

## c. Opioid Settlement

Ray D'Agostino and Jacquelyn Pfursich explained the recent opioid settlement and how municipalities in the County can register for the class action settlement. If all municipalities in the County with a population of over 10,000 sign-on to the settlement, then the amount the County receives will increase.

If municipalities have questions, they should reach out to the Attorney General's office for guidance and assistance.

## 6. Municipal Exchange

# a. Manheim Township

James Drumm reported:

- The Township is currently working to find a replacement for their Fire Chief who is retiring.
- The Township will be replacing their HR Director who just recently started and is now leaving.
- The Stormwater Task Force will delay until the new year to allow the new Board members to decide how to proceed.

## b. East Lampeter Township

Tara Hitchens reported:

• They have new Board members and Planning Commission members starting in the new year.

## c. Columbia Borough

Mark Stivers reported:

- They have a new Council member starting in the new year.
- The Borough is asking the state, and other Boroughs, to take a look at the current Civil Service requirements for Boroughs and hope to update or eliminate those requirements as they are causing issues with the hiring of police officers.
- Columbia Borough has been working with Wrightsville Borough and West
  Hempfield Township on the 462 bridge project. PennDOT has indicated that the
  three municipalities must pay for the maintenance and future replacement of
  bike lane pavement markings, sidewalks, and lighting on this state bridge. The
  municipalities have denied this request. This conversation will continue with
  future meetings.

# d. West Hempfield Township

Andrew Stern reported:

- Reiterated Mark's comments about the 462 bridge issues with PennDOT.
- No changes to their Board.

## e. Lancaster Township

Bill Laudien reported:

- The rezoning request for the new county prison is set for a vote in December.
- No changes will occur on their Board.

## f. East Hempfield Township

Cindy Schweitzer reported:

- No changes to their Board.
- The State Road project is completed.
- The Centerville Road project will soon be starting.
- A couple of bridge projects will soon be starting.

## g. West Lampeter Township

Barry Hershey reported:

- A draft of their new Comprehensive Plan is being reviewed.
- Amanda Hickman has been named Assistant Township Manager.
- They will be working to replace a few retiring police officers.

## h. Manor Township

Ryan Strohecker reported:

- They will have one new member of their Board after the new year.
- The Safe Harbor Trestle Bridge will be substantially complete in January, but formally completed in the Spring.

## i. Lancaster County Planning

Alex Rohrbaugh reported:

- Places 2040 implementation information is all online now.
- LCPC has been reorganized around the planning areas in the County.

## j. Millersville Borough

Lauren Hauck reported:

- Two new Council members will start after the new year.
- They are now a couple of months into their new Comprehensive Plan process.
- The Borough is starting binding arbitration for their police contract.

# k. Lancaster County

Commissioner Ray D'Agostino reported:

- A new budget should be adopted next week with no tax increase.
- They are beginning work on a new Capital Improvement Plan.
- Planning for the next TIP will start soon.
- Federal infrastructure money will be coming into the MPO soon for the TIP.
