The M28-Biomarker Panel Program

The Millennium Health **Store** (aka the "Store") is offering the Millennium's Centers proprietary M28-point Biomarker Panel to our civilian clients. This clinical laboratory test panel has been in use since 2004 for the evaluation of neurosteroids, neuroactive steroids, hormones, and supportive chemistry related to brain health and general wellness. It is presently being used by over 112 facilities for anti-aging medicine (AAM), hormone replacement therapy (HRT), testosterone replacement therapy (TRT), age management medicine (AMM), traumatic brain injury (TBI), and hormone related psychiatric illnesses (HRPI).

Once enrolled in the program, a laboratory draw kit will be sent to you and a trained phlebotomist will come to your location to draw your blood which is shipped overnight to the lab for processing. Within 7-10 days the laboratory printout of the results will be sent to you. Since both Drs. Gordon are not your physicians, the report is for educational purposes only and we highly recommend that you have your healthcare provider review the lab results with you prior to starting any treatment.

We know that many traditional healthcare providers may not be experienced in the interpretation of the Millennium's Biomarker Panel, therefore we offer you an opportunity to obtain a 60-minute consult with Dr. Alison M. Gordon or one of our trained and experienced healthcare providers. At the end of the consult, you will receive an AI generated 12-page report within an informational Patient's Handbook (90-pages).

Steps to Your Assessment (Please read):

- 1. Purchase the Biomarker Panel Program from www.MillenniumHealthStore.com.
- 2. Once you have purchased the program an automatic email will be sent to you containing your enrollment application (request for medical history and any legal disclosures). DO NOT PRINT this document out but fill it in on screen using Adobe Acrobat or similar program.
- 3. Return the entire Enrollment Application to:
- 4. Once your application is reviewed and accepted, you will be contacted as follows:
- 5. <u>Important</u>: During the business week, the laboratory will be notified of your enrollment and the lab will send you a blood-draw-kit with instructions.
 - a. A phlebotomist will be assigned to you, and they will call you to arrange a blood draw on a Monday Thursday before 10am. Please make sure that you adhere to this timing since it is important for the accuracy of the blood draw.
 - b. Do not eat anything for 8-12 hours prior to the blood draw but drink water to stay hydrated.
 - c. Laboratory Contact: If you have not heard from the lab within 48hrs of receiving your kit please call: Shaday Lewis her know that you have received your kit but have not been contacted by the remote blood draw company.

- 6. Once your blood has been drawn, it will be sent overnight to the lab for processing. This can take 5-7 days for us to receive the results and then another 1 3 days to review the results before sending you an uninterpreted copy of the labs for you and your healthcare provider to review.
- 7. After receiving the uninterpreted laboratory results, you may return to the STORE and purchase a 60-minute Video consultation to review the results, in detail, if you did not already pre-purchase it.
 - a. If you **pre-purchased a consultation** with your laboratory testing, Dr. Gordon will send you a 12-page interpretation report (MOA) and a link to a scheduling calendar so you can select a date and time to review your results. This is a 60-minute consultation.
 - b. During the consultation, we will review and discuss your history, lab results, and suggested treatment. At this point, we are only providing education and not acting as your HealthCare Providers. Therefore, you will need to obtain any treatment from your own physician.
 - c. **Patient Handbook**: a 90-page informational packet will be sent to you that holds much of the information discussed during your consultation.
- 8. <u>Clarification of Services Rendered</u>: Since the Millennium Health Store only provides access to the M28 Biomarker and Chemistry panels, we are not assuming the responsibility as your primary healthcare provider. We only primarily provide access to laboratory testing.
 - a. If you elect to engage our doctors in the interpretation of your laboratory results, we again will not take responsibility as your primary healthcare provider. We are providing an educational service. Therefore, we will not be able to provide you with any prescriptions but will advise you as to possible treatment scenarios that you can request from your personal healthcare provider.
 - b. Finally, if after having the M28 Biomarker Panel reviewed with our healthcare provider, you may elect to become a patient of the Millennium Health Centers, Inc.. You would pay the fee directly to the Millennium Health Centers (MHC). (818) 990-1166 x 101.
 - i. This includes an additional 30 minutes of discussion with Dr. Gordon or his representative to confirm your treatment and to provide appropriate prescriptions.
 - ii. Once enrolled in the MHC you will need to have periodical laboratory testing to confirm that we are providing the right solutions for your M28 Panel results. Failure to adhere to these laboratory requirements will affect your access to prescriptions as well as you may be terminated from the program.
 - 1. Initial follow-up labs at 90-120 days.
 - 2. Secondary follow-up at 180-240 days.
 - 3. Annual comprehensive laboratory testing starts 12 months after your original M28 Biomarker panel was drawn.
- 9. You will need to read and sign off on our Medical Service Agreement before you have your laboratory kit sent to you. See Page 2 of the Medical History documents.
