The Camp Rock Financing Plan (CRFP) enables families to spread the balance of their account into manageable weekly or bi-weekly payments. NEW for 2024: Families are responsible for a non-refundable \$30 deposit per week at the time of registration. This deposit will be applied to the total balance owed for camp. Camper registrations are not solidified until parents pay in full or begin making payments for camp through CRFP by the assigned deadline. Payments may begin as early as January 9, 2024. The last day begin payments using the CRFP will be April 16, 2024. After this deadline, all families must have the first two weeks of camp paid for in full prior to enrolling in
