## Sacramento-San Joaquin Delta Watershed Drought & Curtailment Information

The Sacramento-San Joaquin Delta (Delta) watershed is a crucial source of water for much of California for people and the environment. The Delta watershed comprises approximately 20 percent of California’s land mass and constitutes the state’s largest source of surface water supplying a portion of the water supply to two-thirds of Californians and millions of acres of farmland. The Delta is also home to numerous fish, wildlife, and plant species of very high ecological, economic, and cultural importance.

The Delta watershed and all of California is experiencing a second consecutive year of dry conditions, which has resulted in drought or near-drought conditions throughout the state. The combination of unusually low precipitation, warm temperatures, and dry soils have resulted in unprecedented low runoff from the Sierra-Cascade snowpack, resulting in significant reductions in water supplies and extreme low reservoir storage levels. In recognition of these dry conditions, on May 10, 2021, Governor Newsom declared a [drought emergency](#) for 41 counties, including those within the Delta watershed, outlining various actions that the State Water Board and other agencies should take or consider, including curtailments to prohibit diversions when water is not available at a water right holder’s or claimant’s priority of right.

 **Curtailment Status:** Check whether your water right or claim within the Delta watershed is curtailed.

\*These water right claims were not included with the hard copy orders that were mailed on August 20, 2021 (copies of which are posted on this webpage), but should be curtailed until further notice by the State Water Board. Because of deferred notice to riparian claimants with diversions in the Calaveras subwatershed that are outside of the Legal Delta, curtailment of these claims is required as soon as notice is provided but no later than August 27, 2021.

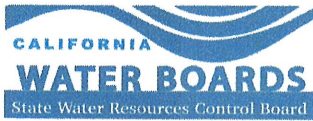

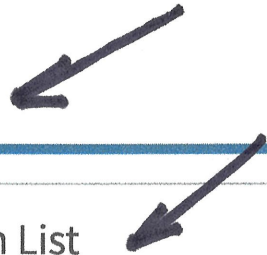

# Water Right Form and Survey Submittal Portal

This site is for electronic filing of Water Right Forms and Surveys (including Information Orders).

The State Water Resources Control Board (State Water Board), Division of Water Rights created this website to provide stakeholders with the ability to electronically file certain water right forms and surveys, and to centralize the location used to collect a variety of information about water rights and water use in California required under Information Orders. In order to access forms and surveys, you must have a user name and password.

If you are an existing user of the Division's Report Management System (RMS) and have a User ID and Password, you may use your RMS User ID and Password to log in. If you own, or file, reports for more than one water right and do not have an RMS account, it is highly recommended that you create one to link your water rights. You may create an RMS account here (<https://rms.waterboards.ca.gov/CreateUser.aspx>).

If you do not want to create an RMS account, you may log in as a "Single User" using your Water Right Number and Reporting Identifier. On your first log-in with each Water Right Number as a Single User, you will be asked for an email address to register the water right in to the system.

This website is NOT the RMS or the electronic Water Rights Information Management System (eWRIMS) and should NOT be used to submit standard reports, including Annual Reports of Permittee, Reports of Licensee, Reports of Stockpond, and Reports of Registration or Groundwater Extraction Records. If you need to submit an Initial Statement of Water Diversion and Use, please see this webpage ([http://www.waterboards.ca.gov/waterrights/publications\\_forms/forms/index.shtml#stmnt](http://www.waterboards.ca.gov/waterrights/publications_forms/forms/index.shtml#stmnt)) for more information.

# Delta Watershed Compliance Certification Form for S018635

## Introduction

### Certification of Compliance Form

All water right holders and claimants who receive an Initial Order Imposing Water Right Curtailment and Reporting Requirements in the Sacramento-San Joaquin Delta Watershed (Order) must complete this Compliance Certification Form (Form) by September 3, 2021, in accordance with California Code of Regulations, title 23, section 879.

This Form requires water right holders and claimants to certify that they will take actions needed to comply with Orders issued pursuant to the Enhanced Water Use Reporting and Curtailment of Diversions emergency regulation ([https://www.waterboards.ca.gov/drought/delta/docs/deltareg\\_oal\\_approval.pdf](https://www.waterboards.ca.gov/drought/delta/docs/deltareg_oal_approval.pdf)) (Cal. Code Regs., tit. 23, § 876.1 et seq.) applicable to the Sacramento-San Joaquin Delta (Delta) watershed. Specifically, this Form requires recipients of Orders issued under the emergency regulation to certify that they are aware of the process by which the State Water Board will notify right holders and claimants in the Delta watershed of the updated status of curtailments and that they are aware of what exceptions apply to curtailment as well as the process for obtaining applicable exceptions.

In accordance with section 876.1, subdivision (c) of the emergency regulation, water right holders or agents of record who receive an Order are responsible for immediately providing notice of the Order to all diverters exercising the water right or claim covered by the Order.

At the end of this Form you must certify, under penalty of perjury, that all the information entered into the Form is true and correct to the best of your knowledge.

To navigate this form, use the "Next" and "Prev" buttons to move forward or backward. On the final page, select the "Finish and Submit" button, which will complete and submit your certification Form. Your responses on each page will be saved when you continue to the next page; however, your Form will not be submitted until you have selected "Finish and Submit."

To view responses for previously submitted Forms under this water right or claim, return to the Water User Dashboard and click "Summary" next to the relevant Form.

This Form must be submitted electronically for every water right or claim for which an Order was issued. Paper copies or emailed submissions will not be accepted.

## Curtailment Notification Process

Future communications regarding changes in water availability, including notification of when curtailments are in place, when curtailments are temporarily suspended or terminated, and when suspended curtailments are reimposed, will be provided only by email through the State Water Board's Delta Drought email distribution list and by posting on the State Water Board's Delta Drought webpage. It is your obligation, as a water right holder, claimant, or agent, to remain informed regarding the curtailment status of your water right or claim. This may be done either by: 1) subscribing to the State Water Board's "Delta Drought" email list ([https://www.waterboards.ca.gov/resources/email\\_subscriptions/swrcb\\_subscribe.html](https://www.waterboards.ca.gov/resources/email_subscriptions/swrcb_subscribe.html)) (located under the Water Rights category); or 2) frequently checking the curtailment status of your water right or claim on the Delta Watershed Curtailment Status List on the State Water Board's Delta Drought Webpage (<https://www.waterboards.ca.gov/drought/delta/>).

- Human Health and Safety: Continued diversions will occur only to the extent that they are to provide for minimum human health and safety needs as described in section 878.1. A Human Health and Safety Exception Form will be submitted for this water right or claim by September 10, 2021.
- Alternative Water Sharing Agreement: I certify that, in the event this water right or claim is curtailed, diversion will cease until a proposed alternative water sharing agreement is approved or a proposed alternative water sharing agreement is submitted pursuant to section 878.2, along with evidence of concurrence with the terms of the agreement by other potentially affected water rights holders and claimants.
