-Mike Mayer presented **the Commissioner's Report**. Check Arbiter daily. Accept and decline games as soon as possible. -Tim Maurer presented the **Rules Interpretation**.

*Trail official "spot" the foul and center official goes to the drop zone. If there is a DOGSO, that is a sendoff offense. Center official should always be approximately 20-25 yards from place. Be receptive to constructive criticism and assistance from more experienced officials. We are asking players to use their hands to spot the ball on all free kicks; however, it is not required. Coaches and players are not permitted to question or dissent every call. After 7th goal differential scored, stop the clock for restart and then the clock keeps running.
