**RE:** Violations of Religious rights and economic warfare against a Religious Priesthood/ Religious Order by the Internal Revenue Service (IRS)

My name is Hashim Ali Jabar, I was given the birth name of Quinn Ryan Foster. My familial home and family seat is found at 2426 Jerome Avenue Dayton, Ohio [45417] (the Thelma M. Foster Estate). I am writing to you as a member of the Rev Dr. Isaiah Henri Harrison Moore and Elizabeth B. Ervin Priesthood (Religious Order), and as leader of our family temple and Consulate- The Zion Church of the Evangelical Association (the Zionst Temple of 1875 for Orphans and Widows) founded November 12, 1875 in Philadelphia, PA, Entity #6101674 (thezionchurch.org). The reason for this communication is because the Internal Revenue Service (also known as the IRS) has and is violating my and my family's religious rights, constitutional rights, and treaty rights. Since 2021, I have provided the IRS with Affidavits regarding monies/ funds/ debts that they claim that I owe to them. The affidavits were both faxed and mailed certified mail. I have

given them ample time to respond to my affidavits of facts. They have not responded to my affidavits but have sent threatening letters instead.

The IRS has not refuted or disputed anything on my affidavits, therefore everything on my affidavits are legally and lawfully found to be true, and therefore the IRS owes me a refund of money. I do not owe them anything, they owe me and my family. The IRS has also received legal notice of the ecclesiastically ordained public record, the Lunar Visitor. Despite my legal and lawful communications, the IRS has continued to send mail to me and my family in an attempt to instill fear, extort my family, and bully their way into illegally taking funds/ money from me and my family.

It is by the divine power of the Holy Spirit, in Jesus's name and in the name of all the prophets that I recognize that Internal Revenue Service has declared a war, an economic war on me and my family and I rebuke them in the name of the Holy Spirit and reserve the right to hold accountable and liable all persons and entities involved.

I stand on the legacy of my grandmothers and grandfathers who have served in the clergy for generations in the United States, who have suffered enslavement, racism, and other forms of oppression including religious. Additionally, I stand on the legacy of my father and grandfather that served the United States military in times of war, in World War II and the Vietnam War.

This Public and Legal Notice serves as an opportunity to all persons listed above to help me protect the religious rights of myself, my family, and members of the Rev. Dr. Isaiah Henri Harrison Moore Priesthood. Religious rights should be taken seriously and with the utmost sincerity and enforced as a constitutional right.

In the most recent efforts of my family, attempting to "live the American dream" and purchase a new home, lenders requested that IRS taxes be paid in full. A whole system has been set in place to act out "economic warfare" and bind my family into a position as a destitute, dependent, and weak.

The Internal Revenue Service has no jurisdiction or authority over me and has refused to provide me with the proper documentation to express this truth to me and others, and additionally it has not provided me with a refund of the monies/ funds that it owes me and my family, that which is properly due. Every letter and communication that I receive from Internal Revenue Service is simply an attempt to extort, bully, and illegally extract our hard-earned money.

My personal and familial records may be found in the Library of Congress in Washington, D.C., on the record at the United States House of Representatives, and in the records at Montgomery County Ohio as an individual flesh and blood human, and as a member of our familial priesthood and religious order.

I reserve the right to defend myself, my family, and priesthood against all physical, spiritual, economic, and other brutal attacks and methods of warfare. I reserve the rights to hold all individuals, corporations, organizations, entities, and other participants liable and accountable for damages, pain and suffering, and time associated with our legal defense.

Everyone listed above has the choice to ignore this communication, assist in helping to resolve this violation of religious rights, or oppose this priesthood in its defense of religious rights.

I am asking assistance with:

- 1. Having all "so-called IRS debts" waived and recalculated to zero
- 2. Ending all threating letters from the IRS that have no bearing
- 3. Receiving a personal refund from monies I paid to the IRS as indicated on affidavits
- 4. Receiving documentation from the IRS indicating my personal and priesthood status as a nontaxable entity free and clear of any and all debts
