Please note that addresses may not be permanent to the structure it is assigned to. Barry County E9-1-1 has the right to change a structures address at any time.

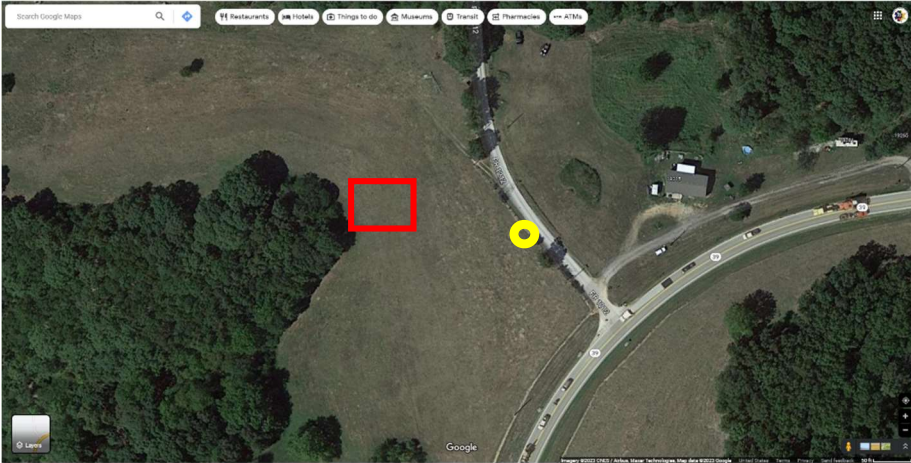
STREET ADDRESSING INFORMATION

- Assignment of an address will be based on the information that is provided by the owner or the owners representative in this application, attached map and on-site physical markings. **IF** access to the structure changes significantly (e.g. a new driveway access is constructed off a new road **or** the access point moves by more than 20 feet) the owner shall request an address correction. **IF** the owner does not request an address correction, Barry County Emergency Services E9-1-1 may correct the address at any given time.
- Private drives / easements may be addressed to an existing adjoining road when they serve no more than two (2) habitable structures. Private drives and easements that server more than two (2) lots or structures will be considered for addressing on a private road, when needed. This would require the existing habitable addressed structures to have their addresses changed to the new private road assigned.
- Access to the property must be allowed for an address to be assigned. If there is a gate prohibiting access, please notify our office with a gate code or other means to access the property.

WHAT QUALIFIES FOR AN ADDRESS

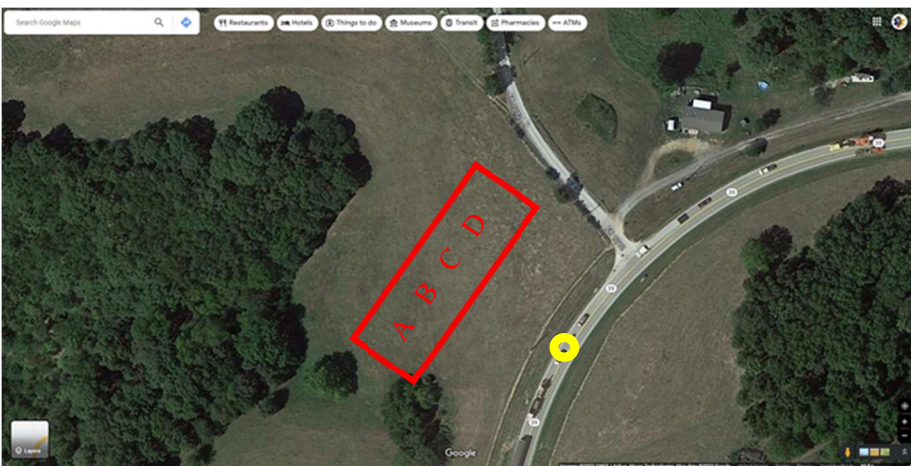
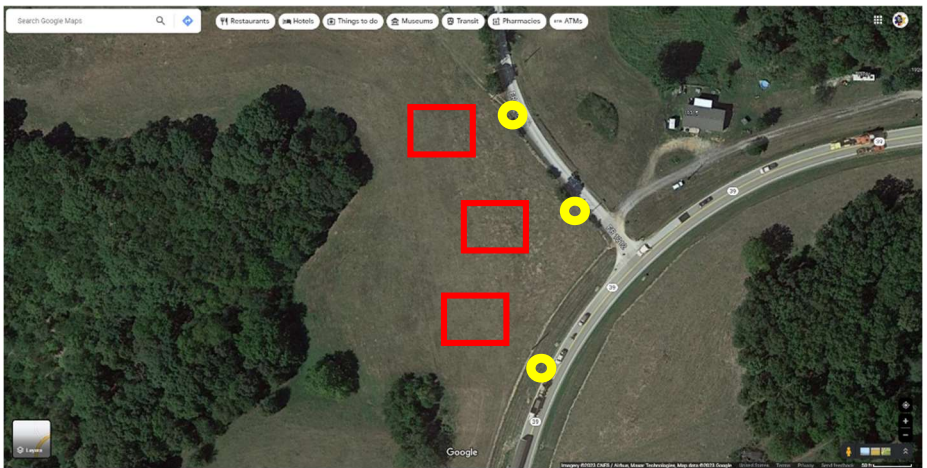
- Habitable Structures (house, apartments, duplexes, mobile homes, Condominiums, etc)
- Mobile Home Park
- Commercial Buildings
- Wireless Towers
 - Vacant lots do **not** qualify for an address.

EXAMPLE STREET ADDRESS SITE PLANS



Simple single address request. The square is indicating the approximate location of the habitable structure. The circle is showing the approximate location of the access point (where the driveway meets the road).

One lot multiple address requests. The squares are indicating the approximate location of the habitable structures. The circles are showing the approximate location of the access points (where the driveway meets the road).



One structure with multiple sub-addresses request. The square is indicating the approximate location of the habitable structure. The circle is showing the approximate location of the access point (where the driveway meets the road). The letters are showing the apartment letters (or numbers). Duplex units receive their own individual addresses.
