These issues will become even more important as our church goes through a self-evaluation, and establishes goals for our future. The Call and Planning Committee will lead this effort, and our goal will be to keep you informed and bring our recommendations, for your approval.

We are also in the process of preparing a budget for 2019. We will present that budget at our October 16<sup>th</sup> Voters Meeting. Keep that date open on your calendar, so you can be sure to attend.

Finally, we will have the election of officers and directors at that October 16<sup>th</sup> Voters Meeting.

I often think of the table prayer, "Heavenly Father, we thank you for your Son and our Savior Jesus Christ, please bless this food to our use, and us to Thy service." ## Apple Dumplings

### Ingredients

- 2 whole Granny Smith apples
- 2 cans (8 Oz. Cans) Crescent Rolls
- 2 sticks Butter
- 1-1/2 cup Sugar
- 1 teaspoon Vanilla
- Cinnamon, to taste
- 1 can (12 Oz.) Mountain Dew soda

### Preparation

Peel and core apples. Cut each apple into 8 slices each. Roll each apple slice in a crescent roll. Place in a 9 x 13 buttered pan.

Melt butter, then add sugar and barely stir. Add vanilla, stir, and pour entire mixture over apples. Pour Mountain Dew around the edges of the pan. Sprinkle with cinnamon and bake at 350 degrees for 40 minutes. Serve with ice cream, and spoon some of the sweet sauces from the pan over the top.

## Council Meeting — August 21, 2018

Vice President Dale Lawson called the meeting to order at 6:30 P.M. and opened with prayer.

The following board members were present: Mic Carlson, Dale Lawson, Susan Kral, Rita Riemann, Vicki Stauch, Chuck Kral, Diane Borgmann, Bob Borgmann, Dawn Hedberg, Russell Schultz, and Bob Mueller.



The minutes from the July 2018 meeting were reviewed and approved as amended. The cemetery C.D. is for twelve months not 24 months.

**President:** Carlson reported the following:

- Giving is not adequate to meet budget, but we are about where we expected to be. He reminded everyone that giving is impacted by membership and attendance. Please continue to invite newcomers and current members who aren't attending to join us. Mic emphasized that we must **NOT** become complacent about giving even though we presently are not paying a pastor's salary. It is **imperative** that we build up funds so that we are able to acquire a pastor and be able to pay his salary. We are also facing major repair or replacement of at least one of our air conditioning units.
- Sale of our excess church property was put on hold at the July 17<sup>th</sup> voters meeting. Mic found the original land survey in the church safety deposit box. The plot upon which the church is located is 15.76 acres. The back plot is 79.86 acres. At the April Voters Meeting, Jeff Emery and Jeff Hedberg reported that we have an approximate 40 foot easement through the power company property immediately to the south of the 79.86 acres on Highway 7.
- Mic and our elders met and discussed membership. The following actions will be taken:
  1. Members who have moved but not transferred will be placed on an INACTIVE roster and removed from the church register.
  2. Members who have not attended for 12 months will be contacted by an elder to determine their status. Those members will be placed on INACTIVE STATUS if they indicate they will not be attending.
- Due to problems regarding nonpayment of Stuart Pepper's portion of the phone bill, Mic will need to set up new accounts for phone and hot spot services. The church's phone number 573-873-6212 will change. The board voted to authorize Mic to obtain telephone service and hot spot service for Peace Lutheran Church.
- Mic met with Jaccy Heinlein regarding Thrivent Action Teams and the raising of funds for our church needs. He would like for elders and officers to meet with him and draw up a list of needs for the church.
- The **Call/Planning Committee** will meet on Wednesday 8/23/18 to discuss what needs to be done to proceed.
- Pastors are scheduled for all Sundays in September.
- Christ the King Lutheran Church is involved in a Comfort Dog Ministry. Information regarding this ministry will be included in the next newsletter.
- Elections will be held at the October Voters Meeting. Dawn Hedberg is chairing the nominating committee. If any member has any suggestions please contact Dawn. A budget for 2019 will also be presented at that meeting.

- Mic contacted the person who thought he knew of a buyer for the baby grand piano. That person does not know of an interested party. The board voted to authorize Mic to put the piano on Craig's List.

**Financial Secretary:** Vicki

Stauch presented her report. Total giving for the year is below budget. Giving is approximately \$1,000.00 less each month than is needed. The report was accepted and approved.

**Treasurer:** Rita Riemann presented the Treasurer Report. The July checkbook balance is \$5,728.15. July deposits totaled \$7,170.69. Monthly expenses totaled \$2,217.74. The difference is \$4,952.95. She did not receive a July Southwest Electric Bill. There will probably be a late fee added to it. Rita's report was accepted and approved.

**Elders:** Bob Mueller stated that the elders are working on updating the church's membership roster. He thanked Bob Borgmann for fixing the microphones used by the elders and the pastors. He thanked Mic Carlson for getting sermons for the elders when needed and for all the extra work that Mic has done because of the release of Stuart Pepper. Bob's report was approved and accepted.

**Ushers:** Bob Borgmann reported that he ran new microphone wires from the rear of the church to the altar. Now three microphones can be used simultaneously. His report was approved and accepted. The board thanked Bob for his work.

**Member at Large:** No report

**Trustees:** Chuck Kral reported the following:

- When the weather is cooler, Chuck will need help filling in holes at the cemetery where animals have been digging. Dirt will need to be brought in.
- The new thermostats are scheduled to be installed on Monday, August 27.

- Prior to tonight’s meeting, he discovered that the air conditioning unit that cools the back of the church was iced up and leaking into the basement. He will contact McGuire Heating and Cooling. Hopefully they will be able to repair the unit when they come to install the thermostats.

The report was approved and accepted.

**Education:** Vacant

**Evangelism:** Russell Schultz presented letter that he would like to email to Missouri Synod churches inviting their members to visit Peace Lutheran if they are visiting our area. The board approved his proposal.

When our website is updated Russell will “like” other churches and invite them to “like” us. Mic Carlson has found a person who is willing to help update the site.

The report was approved and accepted.

**Stewardship:** No report

**Cemetery:** Diane Borgmann reported the following:

1. The Bank of Versailles offered to increase the interest on our C.D. to 1.5 percent as an apology for the difficulty members experienced in changing signature cards.
2. Our C.D. is currently valued at \$20,092.75.
3. The cemetery checking balance is \$2,467.99.

The report was accepted and approved.

The meeting was adjourned, and Mic closed with prayer.

## Nomination and Election of Odd Year Officers and Directors

The following officers and directors will be nominated and elected at our October 16 voters meeting: *President, Secretary, Financial Secretary, one Elder, one Trustee and the Director of Evangelism.* We also need to find candidates to complete the second year of the terms for Vice President and Director of Education. Dawn Hedberg chairs the Nominating Committee, and together **we ask each of you to give prayerful consideration to accepting the nomination to one of these positions.** Generally these positions do not require significant amounts of the volunteer’s time, but there is a time commitment. The Director positions are handled best by someone who can recruit others to also serve and assist. In addition to the requirements of the position, there is the commitment to attend a church Council Meeting held the second Tuesday of each month at 6:30 pm. These can last anywhere from one hour to two hours. The President is also responsible for appointing committees for audit, budget, nominating, planning/call. There is a job for everyone here at our congregation. You don’t have to wait to be asked, volunteer to serve in one of these important positions at Peace.

Obviously we have people who serve in multiple capacities, as an example, each of the Elders also serve as ushers. Also there are a number of jobs that are not filled, but should be. Finally this matrix does not include the organists, greeters and coffee servers, mowers, LWML, Thrivent or Stephens Ministry, nor does it include the people who volunteer time to help with all of the other special events at church, like putting up and taking down the Christmas decorations, spring cleaning etc.

*I truly appreciate everything that each of you do for the church, however, I urge you to consider taking on one more task, or additional tasks as we work our way through this “new beginnings” year. Thanks!!*
