SALES CONTRACT

All *Queen City Cane Corso* puppies, unless specified above, are sold with Club registration papers and a two (2) year guarantee against puppy crippled by congenital hip dysplasia, In order for this health guarantee to be valid, the following conditions must be met:

- 1) All puppies must carry the *Queen City Cane Corso* name on the registration papers. Said dog remains current on all vaccinations and dewormings, including all puppy shots recommended by a licensed veterinarian. The next vaccination is due on:

- 2) Purchaser must follow Dietary and Activity Guidelines provided by the breeder. Any Purchaser with a puppy crippled by this congenital defect must present the breeder with a certified letter as well as x-rays from a licensed veterinarian within one week (7 days) of finding the defect. Said dog must then be returned to the breeder along with registration papers. A replacement puppy of equal or greater value will be given to the buyer, as soon as one becomes available.
- 3) Purchaser must provide proof that said puppy has completed basic obedience training with a professional trainer or group puppy training class.
- 4) Puppies need to be checked by your own licensed vet within 3 business days of receiving the pup to verify the puppy's good health upon arrival and to ensure you will continue to have your pup under good care.
- 5) Puppies/Dog is not allowed to be used in any illegal activities or in any breeding to dogs of another type of breed or to a Cane Corso of inferior quality. *Queen City Cane Corso* will be happy to assist your in finding an appropriate mate for your *Queen City Cane Corso*. Our dogs are of superior breeding and it is our desire that their offspring carry the same quality both in temperament and conformation.
- 6) If you are no longer able to keep the puppy/dog, Queen City has the first option to receive the puppy/dog back or to assist owner in finding a suitable home.
- 7) If puppy/dog is abused in any way (including, but not limited to, being kept on a chain) Queen City Cane Corso has right to reclaim the dog at any time, with no compensation made.
- 8) Under no circumstance do we grant cash refunds or except any liability for medical expense, veterinary fees or any other expense related to the care of your Queen City Cane Corso.
- 9) Cherry Eye, Entropion and Ectropion are common conditions with all Mollosler breeds and are not covered by our guarantee.
- 10) Contract is good for original buyer only.
- 11) Any breeching of this contract will make it void.
- 12) Any and all lawsuits brought against Queen City Cane Corso must be filed in Prince Georges County, Maryland.

Queen City Cane Corso has no other guarantee other than those stated on this document. By signing this contract purchaser and seller/breeder agree to hold to their part of the agreement.
