

ALL CHURCH MEETING MINUTES

December 14, 2023

The meeting was called to order by Moderator Terry Putnam at 7:05 pm followed by an opening prayer by Kirsten Allhusen. A motion was made to accept the Minutes of the November 12th All-Church Meeting which was seconded and passed unanimously.

Pastoral Relations

Bob Franzen said his group met recently with Rev. Paul by email. No issues were determined and he will schedule an in-person meeting early in 2024.

Building & Grounds

Eric Nitsch reported he has signed the contract with Valley Roofing and paid the deposit on behalf of the church. Work is scheduled to begin late March or early April. The church's building inspection was recently done and we have an occupancy permit. The church's manger scene was set up on the town green and a nice outdoor ceremony was held by Rev. Paul on Nov. 25th that was well attended. Eric had an energy audit done of the church which showed many areas of the church were not insulated. Some of the recommendations by the audit will be completed free of charge but Eric is also waiting for a quote on the cost of projects not covered. The annual snowplowing contract is all set.

Boy Scouts

Eric Nitsch, representing the church. has signed the annual Boy Scout Charter with Ron Hall.

Christian Ed

Kirsten Allhusen reported things are going well with her core group of four children. She is planning to have the youth take over a future Sunday service and inquired about the sound system the church has. She is looking for storage space for supplies.

Finance

Melanie Nitsch reported a rental increase letter was sent to the tenants. Rent will increase by \$50 per month as of 2/1/24 making the rent charged to be \$1,600 per month. Virgil Paggen has informed the Committee he will be stepping down from his roles in Stewardship which included weekly counting of the offering as well as managing the church's Stewardship campaign. We can't thank him enough for his close to ten years or service. He has been a pillar of confidentiality in maintaining the Stewardship financial records. Melanie and Jim Putnam will be speaking with the

Executive Committee about our plans going forward. Stewardship letters went out at the end of November and everyone is reminded to turn in their pledge cards as soon as possible. The Holly Bazaar went very well with the wonderful Holly Inn. Approx. \$2,000 was deposited but expenses still need to be deducted. Jim as asked to send a contribution of \$1,000 to the SNEUCC for 2023. All committees are asked to look at their budgets and submit to Finance for early January and to turn in their Annual Committee Reports to the office by mid-January. The church has a \$175 refund from the Dept. of Unemployment Assistance they are holding on account for us. Joseph will work on applying for that refund. Lastly, the church's domain has been hosted by Doodlekit which is going out of business. Joseph has been researching and it has been decided we will switch to Go-Daddy at a cost of approx. \$156 per year.

Due to the change in housing allowing for the pastor from \$15,000 annually to \$10,000 annually, the following motion was made, seconded, and passed unanimously:

"Beginning January 1, 2024, the housing allowance paid to Rev. Paul Nesbit shall be \$10,000 annually, paid in bi-monthly installments of \$416.67. This amount shall be designated as a housing allowance pursuant to Section 107 of the Internal Revenue Code. Furthermore, the designation of \$10,000 as an annual housing allowance shall apply to 2024 and to all future years unless otherwise provided."

Pastor's Report

There will be a Blue Christmas Service on Wednesday 12/20 at 7 pm at Second Congregational Church in Westfield. Rev. Paul's Christmas Eve schedule is as follows:

9:30 am service in Westfield for both churches, 1 pm service at Southwick Villages, 4:30 pm candlelight service in Westfield, 6:30 pm candlelight service in Southwick. The Associate Conference Minister Terry Ogawa will attend our Jubilee Celebration to be scheduled with a church service and then followed possibly by a historical presentation.

Deacons

Dawn Turgeon reported they are all set for Advent readers and will do the traditional bell ringing during hymns at the Dec. 31st combined service at our church with Southwick and Westfield. Chrismon Sunday will be Dec. 17th and the manger on the altar will be all set up.

Memorial Gifts

Funds have been used to pay the deposit on the roofing project.

Treasurer's Report

Jim Putnam reported an approx. \$13,000 operating deficit in our budget which is better than expected. He is working on gathering pledges for 2024.

Executive Board Meeting

The committee met immediately following the All-Church meeting so that Finance Committee could share their thoughts and plans going forward for the weekly counting and recording of pledges. Going forward, all Stewardship financial records will be maintained on the church's office computer. Jim Putnam made a motion to authorize our office administrative assistant, Joseph, acting as system administrator, to change the password to the office computer and to issue it only to the Moderator, the Treasurer, the Chair of Finance, and the Minister. The motion was seconded and after discussion of how often the password should be changed, was approved unanimously. Virgil Paggen has provided Melanie and Jim with all his financial records and working spreadsheets so the process can continue confidentially and accurately, as has been the case for many years.


