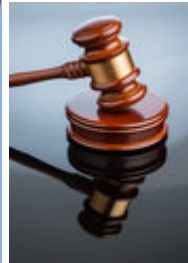

And, we've been featured in some local publications. Perhaps these efforts have born some fruit as we have around an average of three new members every month. I'm hopeful that we are returning the club to growth vs. decline.

Regarding the upcoming Member-Guest tournament. As a reminder, this is an event that we traditionally try to make just a little nicer than our standard out-of-towns so that we can invite our spouses and sometimes bring friends and family to join us in our enjoyment of the game. Therefore, it tends to cost more than our normal out-of-town events. This year I attempted to keep the price as low as possible while keeping the venue both nice and nearby. However, due to unforeseen medical and financial issues for some, the number of attendees is now in the low/mid 20s, though some additional members may yet opt to attend. We have to release the rooms we don't assign back to venue on September 1<sup>st</sup>. The ability for folks to attend after that point will depend on availability at the venue. We may also incur a small loss due to failing to meet the contracted room. If you would still like to attend, contact me and I'll see if we can find a room at the venue for you.

A number of things were covered this month at the Board of Directors meeting. One of them included the requirement of the president to plan and host a member-guest event. Given the increasing costs of lodging, food, gas and green fees, we anticipate costs for future member-guest tournaments will only increase. Therefore, we voted give the president the ability to opt not to hold a member guest tournament if need be. We also provided guidance that the president will have broad discretion regarding the composition of that tournament.

Other things covered at the BOD meeting included:

- We voted to have the table open one hour prior to tee-time (vs. 90 minutes) and close one-half hour prior to tee time starting in 2024.
- We discussed, but took no action on: Joining the GSGA, tee adjustments, and having super-senior tees.
- We opted to discontinue utilizing the calling post (which we haven't used in some time).
- Ron Wade discussed difficulties in finding a reasonably priced venue for the 2024 member guest
- We determined that the New Member Handbook needs to be updated. Ron Wade will do this.
- We are looking for a new source for bag-tags and awards, as well as looking for someone to take over as Awards Committee chairman.
- And we discussed the loss of Cotton Fields and emerging issues with Southland.

We are looking forward to the end of year banquet, and have narrowed the potential venues down to three, we'll let you know where and when it will be as soon as we finalized the details.

Now, for some reminders of things that you should all already know:

- Please start on the hole that the table assigns. If you are in the final group, please do not drop back a hole or two.
- Please be careful to fill out scorecards correctly and legibly. The most critical thing is being sure to have a score, the correct score, posted for each hole. Failing to do this disqualifies the player. It also helps if you do the math correctly.
- When you fill out your score cards prior to the round, include the player's name, member number, and handicap (Flight and Points. e.g.: A-25, B-18, etc.)
- Don't tee up your balls in the fairway. The only place we use tees is in the tee-box.

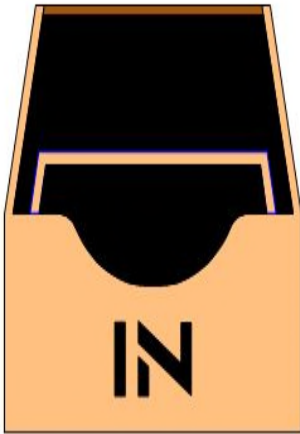

Traditions evolve in all organizations. Some are sacred cows and others are considered trivial by the uninitiated. However, over time even the most sacred traditions are challenged, either from inside the organization or by developments in the environment in which the organization operates. Threats to traditions may cause instability in the organization.

Among the traditions of SGAA are our registration and payment policies and the annual Member/Guest tournament. These traditions are being challenged, and in this article we will explore the challenges and some possible consequences.

Until recently, members registered for our regular tournaments on the day of the tournament. The member paid the tournament fee at registration, and paid the green fees to the course. Members were rarely turned away, and then only when the course could not supply enough carts.

The adoption of the preregistration process made this tradition obsolete. This process facilitates advance hole assignments by the table crews and enables us to provide more current and complete information to the courses about the expected number of players. Advance payment is not required, members are not penalized for not playing and players who do not preregister are allowed to play. The process is working effectively.

Even this improved process is being challenged. Because of increasing demand, courses are insisting that we provide more accurate and current information about the number of players expected. There are indications that some courses may require a guarantee of the number of starts we reserve. Moreover, one course has informed us that SGAA will be required to pay all green fees by check or credit card rather than each individual paying.

Your board is actively studying these developments. While no changes to our current practices have been identified, we will probably be required to refine our procedures further.

The Member/Guest tradition is under serious pressure for these reasons.

- Golf demand remained steady during the pandemic because golf was one of the few outdoor activities which was considered relatively safe.
- Demand has increased dramatically since the end of the pandemic.
- Member participation has decreased sharply. Only 20 golfers have committed for the 2023 Member/Guest, down from only 30 in 2022.
- Inflation has had a profound effect on the projected cost of the Member/Guest. Preliminary proposals for the 2024 Member/Guest exceed \$1200 excluding awards and entertainment. Notably, room costs are being quoted at rates which are double the rates paid 5 years ago.

SGAA bylaws have previously required that the President arrange an annual Member/Guest in September or October with the approval of the Board. In view of the factors enumerated above, at its August meeting the Board amended the bylaws to provide that the President *MAY* arrange such a tournament. While we will diligently continue to attempt to arrange a tournament for 2024, the format of the tournament is likely to change, and there is no assurance that we will be successful.

## ARE YOU MAN ENOUGH TO DO THE JOB??

The summer is winding down and our focus is shifting to our Annual Tournament followed quickly by the Member-Guest at Lake Junaluska. Both of these are very important activities, but I draw your attention to the most important event of the SGAA calendar – the nomination and election of officers for the coming year.

At the End of Year Banquet set for Thursday, November 16<sup>th</sup>, we will be electing the President and the Vice President each for a one-year term; a Treasurer for a two-year term; and three new Directors each for a three-year term. These gentlemen will be joining the Secretary and the remaining Directors to provide the SGAA Leadership for 2024.

The Nominating Committee chaired by Dave Mueller and assisted by Ted Pogue, Jim Begnaud, and Kerry Phillips has been hard at work pulling together a slate of candidates from which you elect the new officers. A preliminary slate is presented in this Newsletter, but the By-Laws require the slate be finalized by September 15<sup>th</sup> so the membership will be notified two months prior to the election.

The finalized slate of candidates with their bio's will be provided in the October and the November Newsletters. A ballot with instructions on how to cast your ballot will be included in the November edition of the Newsletter.

All of this leads to the question: Are you man enough to do the job??



# ANNUAL TOURNAMENT INFORMATION



Our Annual Tournament begins on **Tuesday, September 5th at Bear Creek Golf Course**. Tee time is 8:30 AM for all rounds of the tournament. There is a special one-time table fee of \$10.00 to be paid at the start of your tournament play. Green fees (\$36.00) are to be paid to the course before each round. There are 9 rounds scheduled for this tournament. You may play as many rounds during the tournament schedule as you like, but you MUST PLAY a minimum of 4 rounds to be considered as competing in the Annual Tournament. No matter how many rounds you complete during the Annual Tournament, your 4 best

rounds will be used to determine your tournament standing.

The standard pre-registration applies to the tournament. You do not have to enter the tournament to play. You may also just show up, notify the table of your intentions, get a hole assignment, and pay your green fee.

The following SGAA rules are provided as a refresher as we begin tournament play. Additional information may be provided by the Table Captains, or on the SGAA website, as the tournament progresses.

1. Rules of Play—USGA, PGA and local course rules shall govern play except as listed below. While SGAA Rules may seem to be very tolerant it is for the benefit of members of the Senior Golfers Association of Atlanta and to promote speedier play. Any member or members wishing to abide strictly by USGA and PGA rules are welcome to do so.
2. A PLAYER--May pick up to identify, clean or exchange a ball that comes to rest anywhere within the boundaries of the golf course and replace the ball one club length, or within one club length, no closer to the hole without penalty except on the green (see rule #3), or in a sand trap (see rule #4). The ball must be placed in the same general environment (1st cut, 2nd cut, rough, etc.) as it originally came to rest. If a ball cannot be played within one club length and still considered unplayable it can be moved any distance on a line of entry back towards the last point the ball was struck with a one stroke penalty.
3. ON THE GREEN—A player may mark the ball's location and pick up to identify, clean or exchange his ball. Ball must be replaced at the mark where it was picked up.
4. SAND TRAP PLAY—If your ball is in a fairway bunker or greenside sand trap and lies in a foot print (human or otherwise), any untended sand marks from previous a player, or maintenance equipment, you can pick up your ball, rake the area of untended marks and replace your ball in the same spot without penalty. Also, any ball resting in water or mud can be pulled out and placed one club length no closer to the hole but still in the trap or bunker, without a penalty.
5. BALL OUT OF BOUNDS, UNPLAYABLE or LOST—When a ball is hit out of bounds, declared unplayable (see rule #2) or lost, after searching for a maximum of three (3) minutes, the player may place his ball any distance along the flight of the ball where the ball went out of bounds, is presumed lost or determined unplayable. A one (1)-stroke penalty shall be counted.

6. 14 CLUB RULE—Each player shall have no more than 14 clubs in his bag or face disqualification from that round.

7. DROP LOCATION—A ball hit into a water hazard must be marked off from the side of initial entry into that hazard as stated above (where the ball first crossed the yellow line).

8. GUEST PLAY—Members may bring a guest during the year except to the Annual Tournament, or other designated tournaments when published to the membership. However, members have priority in the event of a cart shortage. The cards for this foursome will be held by the table captain until all member players have checked in, holes and carts assigned. After this time, the foursome with a guest can be assigned a hole. As stated, in the event of cart shortage the guest will not be allowed to play and the remainder of that foursome has the choice of playing (if there are openings in a group) or not playing. Never will an SGAA member be asked to leave and a guest allowed to play.

### ***In Memorium***

# WELCOME TO OUR COUNTRY CLUB

## Here are some of the Country Club Rules:

- Proper golf attire and footwear are required for the course and practice areas  
The dress code is enforced (If you don't know what proper golf attire is - ask the Golf Shop staff)
- Respect private property. STAY OUT of private homeowner property.
- All alcoholic beverages and coolers must be obtained through the Country Club.
- No personal coolers allowed without explicit permission from the Golf Shop or Starting Official.
- No glass containers of any kind may be brought onto the golf course property.

- YOU are responsible for your own ball and what it hits - NOT the Country Club.
- Fill divots, rake traps, and repair ball marks.
- Keep Pace of Play. Only 2 hrs. for 9 holes & 4 hrs. for 18 holes.
- The Course Marshal will have the authority to ask players violating these rules and/or displaying improper conduct to leave the course without a refund.

If you cannot respect and obey these rules, you need to go somewhere else.
