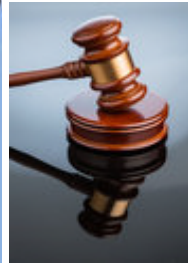

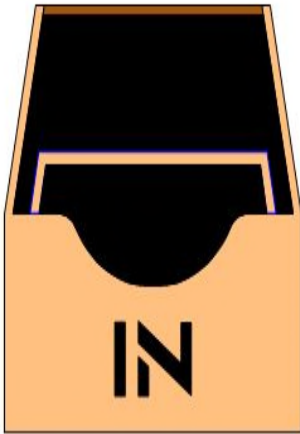

As you are reading this, we are wrapping up our 2024 Member/Guest tournament at Lake Junaluska. This year's event was only possible because of President Larry's tenaciousness in negotiating an affordable event. The venue has been cooperative, but the first several proposals were clearly out of our budget range, but we were finally able to conclude satisfactory arrangements because Larry hung tough.

The difficulties in arranging a M/G tournament in the future will only increase, and it is questionable whether we will be able to continue annual tournaments. As Larry has previously reported, all of the cost elements of outings have increased sharply over the last three or four years. For example, the cost of lodging has increased more than 30% since 2020.

We recently surveyed members about the importance and cost of the Member/Guest tournament and other of town events. Of the 30 respondents to the survey, only 3 consider the M/G tournament to be "Very important" to the SGAA culture, whereas 27 respondents consider other out of town events to be "Very important." Fully half of the respondents believe that the maximum cost of the M/G tournament per golfer should be less than \$700, and the maximum cost per member and spouse should be less than \$1,000. Our experiences in 2022 and 2023 clearly indicate that we will have considerable difficulty with these limitations.

We have begun to explore opportunities for a 2024 M/G tournament. Several venues have been eliminated because of cost or for other reasons, but we are in active contact with 2 venues. While we are hopeful that an affordable tournament can be arranged, it is possible that the format may be modified; for example, we may be able to limit lodging and meal requirements by beginning play at noon on the first day as we do in other out of town tournaments. If you have suggestions, please contact any officer or board member.

Incidentally, we have recently revised the New Member Handbook, and it has been posted to the site.

But the Year End Banquet isn't the end of the season; we've got more golf scheduled through early December.

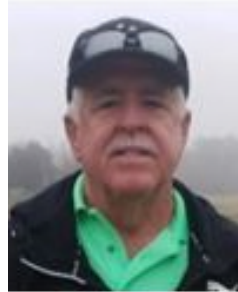
