TRANSIENT RETAIL BUSINESS – SOLICITATION PERMITS

Ordinance #323, Section 51.

- a) Engaging in peddling, canvassing, soliciting or taking orders, either by sample or otherwise, for any goods, wares or merchandise, upon any of the streets or alleys, sidewalks or public grounds, or from house to house, within the borough of Forest City; and
- b) Selling, soliciting or taking orders for any goods, wares or merchandise, from a fixed location within the Borough, on a temporary basis, which shall include, but shall not be limited to, such activities conducted at the time of special occasions or celebrations, for seasonal purposes, or for or in advance of specific yearly holidays.

Section 52. Fees revised 8/1991 - No person shall engage in Transient Retail Business within the Borough of Forest City, without first having obtained a license, for which the following fee is charged, which will be for the use of the Borough:

- a) Four dollars (\$4.00) for one day;
- b) Ten dollars (\$10.00) for one calendar week or fraction;
- c) Twenty Dollars (\$20.00) for one calendar month or fraction thereof;
- d) One Hundred dollars (\$100.00) for one calendar year or fraction thereof.

No license fee under this section for:

- a) Farmers selling their own produce;
- b) The sale of goods, wares & merchandise, donated by others for charitable or philanthropic purpose; or
- c) Any manufacturer or producer of milk or milk products, bread and bakery products, or meat or meat products.

Section 55. Prohibited Acts – No person engaging in any transient retail business in the borough of Forest City shall:

- a) Sell any product or type of product not mentioned in the license;
- b) Hawk or cry his wares upon any of the streets, alleys, sidewalks or public grounds of the Borough;
- c) When selling from a vehicle, stop or park on any street or alley for any longer than necessary in order to sell to persons residing or working in the immediate vicinity;
- d) Park on any street or alley for the purpose of sorting, rearranging or cleaning any goods, wares or merchandise, or disposing of any carton or wrapping material, any stock, wares or foodstuffs which have become unsaleable through handling, age or otherwise;
- e) When working house to house, shall not engage in business on Sunday or before 9:00 a.m. or after 7:00 p.m. on any other day of the week.
