Also, we had one winner who remains unidentified. We are reaching out to locate the person. Our next Lottery campaign will be for the Easter season.

- f) **Summer Advertising** Ed recommended we promote our club throughout the summer periodically. All were in favor however, nothing formal was discussed at this meeting. Dan Sonnenberg stressed promoting the use of both Facebook and the website to our advantage.
- g) **Club House** Discussions were abound in how to go about securing finances for this project.
