on July 20, 2023 @ approximately 12:48am while Katrina Hermanson was in Rimrock, Arizona. Ms. Hermanson was sitting outside waiting for her friend when she witnessed 2 beams of light

going across the sky. She used a moto g phone powered by android to snap a picture of what she was seeing. She says the lights bolted across the sky until out of her view. She has nothing more to report regarding the sighting.

## Incident Report #2

On July 20, 2023 @ approximately 2:31am Katrina Hermanson was still in Rimrock, Arizona. While still sitting outside Ms. Hermanson seen another light in the sky. She took 2 pictures with her moto g phone powered by android of the light. She states that she looked up and another light was going fast across the sky just like the first incident accept there was only one light and not two.

Narrative by ASDP Arizona Ufologist Jodi Lynn Brown. I spoke with Ms. Katrina Hermanson on my cell phone Tuesday August 8, 2023 @ approximately 3:18pm regarding her eyewitness account and her photographed evidence of a flying object that appears to be 3 different crafts. Two different crafts are captured in the first photo. The top craft appearing in a purple/pink haze is known as a tube craft. The second craft in the photo has not yet been identified. The craft appearing in the next two photos have not yet been identified. The first photograph has been checked for authenticity by Mr. Anibal Quinones. The Second photograph first photo has been checked by Mr. Anibal Quinones for authenticity. The Second photograph second photo has not yet been checked for authenticity. This temporarily concludes this investigation conducted by ASDP Arizona Ufologist- Jodi Lynn Brown. until further information is collected on the other two types of craft that remain unidentified.
