Joint House Resolution Emergency Session Reading dated August 29, 2023 Issued for Resolution Forbearing the Elections for September 2023, Due to the Discrepancies and Inconsistencies Found During the Ongoing Full Investigation Being Conducted by the Joint Congressional Investigation Committee

Joint Session of the 27th Congress

JHR 90-08-27-2023

Proposed by the Joint Congressional Investigation Committee

Be it resolved by the House of Representatives and the Senate of the republic of Texas, One Nation under One God, in congress assembled, a resolution proposed by the Joint Houses of the twenty-seventh Congress of the republic of Texas.

After the people's congressional House of Representatives and the Senate, in an emergency meeting of Congress assembled, which approved and adopted: House Resolution No. JHR 90-08-27-2023 originating from the Joint Congressional Investigation Committee, is titled:

Resolution Forbearing the Elections for September 2023, Due to the Discrepancies and Inconsistencies Found During the Ongoing Full Investigation Being Conducted by the Joint Congressional Investigation Committee

On August 17, 2023, the 27th House of Representatives voted and passed the motions starting an investigation, creating and adopting an investigation committee.

On August 28, 2023, the 27th Senate voted and passed the motions starting an investigation, creating and adopting an investigation committee.

Due to the inconsistencies regarding the elections, we are forbearing the election date for thirty days, until the following inconsistencies and additional questions from this investigation are answered and determined satisfactory by the investigation committee.

- August 12, 2023: The secretary of state said, "Elections were not going to happen."
- August 18, 2023: The secretary of state sent out voter roll emails.
- August 18, 2023: The ballots were uploaded to the republic of Texas website.
- The ballots that were released had missing candidates.
- The required postmark for returning the ballots was dated September 5, 2023.
- The republic of Texas website added a note the ballots were due by August 31, 2023.
- On the ballot it states "WARNING!!! Failure to follow instructions may disqualify your vote. Ballot must be postmarked no later than September 5, 2023."
- There are discrepancies regarding the eligibility of some candidates which could cause them to be ineligible.
- There is incongruity between the elected officials' sworn oaths of office and affidavits with their non-disclosure agreements that are used in corporate jurisdiction.

In the event the joint congressional investigation committee requires more time, they will notify congress, in writing, of the required additional time in thirty-day increments.

Sec. 1. Be it resolved this resolution will forbear the election for thirty days effective starting August 31, 2023.

Sec. 2. Be it resolved that the full investigation by the joint congressional investigation committee shall include but is not limited to: continuing the process of obtaining testimonies from anyone who has evidence that has been uncovered during the investigation. The investigation committee shall research any/and all other questions, evidence, testimony, information, etc. that it deems necessary.

This resolution shall take effect from and after the day it is passed and thereafter once signed.
