JOURNAL ENTRIES

AMENDED INDICTMENT FILED IN OPEN COURT.

Mr. Morey advised he had intended to do a written entry of plea, but has authority to enter a plea on behalf of the Defendant. Court noted it does not have a formal waiver of appearance.

NEGOTIATIONS are as contained in the Guilty Plea Agreement FILED IN OPEN COURT. DEFT. PLED GUILTY TO COUNT 1 - COERCION (M) and COUNT 2 - BATTERY (M) IN ABSENTIA.

Court ACCEPTED plea and, sitting as MAGISTRATE, ADJUDGED DEFENDANT GUILTY as PLED. COURT ORDERED, in addition to the \$25.00 Administrative Assessment fee and a \$975.00 FINE, Deft. SENTENCED as to COUNT 1- to Clark County Detention Center (CCDC) for SIX (6) MONTHS and as to COUNT 2 - to Clark County Detention Center (CCDC) for SIX (6) MONTHS to run CONCURRENT with Count 1, SUSPENDED; placed on INFORMAL PROBATION. CONDITIONS:

1. Pay \$975.00 or complete 97 hours Community Service.
2. Have no contact whatsoever with the named victim.
3. Stay out of trouble.
4. Comply with all court orders.
5. Attend and complete an anger management class.
