Myself and Det.Tennant P#6763 then interviewed Elizabeth. She confirmed all of what Det. Collins had told me in regards to the trouble they are having in their marriage and also that an altercation had occurred on their

16th. Elizabeth told us that on the 16th she was sitting on the couch in their house. She said that Daniel called to her telling her to come into the bedroom. She said that she told him that she did not want to come. He told her again to come and that it would only take a second. She got up and went to him. She said that onderin: the room Daniel's demeanor was angry and that he positioned her back toward the back of the bedroom. She said that as he advanced on her forcing her to walk back, he was telling her "I want to fuck, let's fuck". She said that she told him no but that he kept saying it. She said that once she was backed against the wall, he got down on his knees in front of her and unbuttoned her pants pulling them down. She said that she grabbed her pants trying to prevent him from doing so telling him to stop that she did not want to have sex. She said that she was crying and thought about trying to call someone for help with the phone that she had pants pocket but that she would have to let go of her pants to get it. She said that Daniel did get her pants down, but her underwear remained up. She said that she pulled her pants back up and buttoned them, but that he immediately unbuttoned and pulled them back down. She said that he kept saying he "wanted to fuck". She said that during the course of this altercation, Daniel placed his hand on her vagina on the outside of her underwear. She said that it ended with him stopping getting up and saying that he was just joking. She said that he told her that he had thought that she was cheating on him. That he had seen a pair of her underwear in the bathroom and it looked like there was semen in them. Which she told him that there was not it was normal female discharge.

Det. Tennant and I then interviewed Daniel. I gave Daniel his Miranda rights which he stated that he left is understood. I said that we wanted to talk to him about something that had happened with Elizabeth onto Sunday. His response was "I want to remain silent". He was then placed under arrest for Open and Gross is Lewdness. As we were traveling to jail Daniel changed his mind saying that he wanted to give me his a statement. We went back on tape and I re-Mirandized him again. I then asked him if he felt that neither Det. Tennant and I had threaten, intimidated, made an promises, physically assaulted him in any way to force him to give a statement. He said that we did not and he was consensually providing us with his statement.

He said that he and his wife have been having problems and he suspected that she was cheating on him. He said that he wanted to do something scare her to get her attention. Something that would be out of character for him but that she would know that he was serious. He said that he planned out the scenario in advance and called Elizabeth into the room. He said that once in the room he placed his hands on her shoulders, pushing her back into the room and eventually against the wall. He said he was telling her "Let's fuck, I want to fuck, come on let's fuck. It won't mean anything it's just sex". He said "I'm horny, I want to fuck. What's he got that I don't have. Does he have a big cock? "I'm your husband. I just want to know what I'm up against". He said that he kept saying this over and over again. He said that he got down on his knees in front of her and pulled her pants down. He said that she was telling him that she did not want to have sex and to stop. He said that she pulled her pants back up and that he pulled them down again. He says that he did touch her on her bare hipflexor but says that he did not touch her vagina. He said that eventually he stopped and said that he was just joking and just wanted to get her attention.

Based on the above Daniel was arrested for Open and Gross Lewdness for touching without penetrating Elizabeth's vagina. He was transported to CCDC and booked
