What Is CLIC?

The Community Legal Information Center provides free legal information to community members and students who need assistance with legal issues. CLIC is made up of eleven different programs that specialize in different aspects of the law. It is staffed by students enrolled at California State University, Chico and is supervised by four university professors, all of which are licensed attorneys.

CLIC provides CSU, Chico students, primarily Legal Studies majors, internship opportunities that offer up to 3 units of upper division credit. This internship allows students to engage with clients while researching legal information in a professional office setting, giving them real world experience in specific fields of law.

CLIC is a non-profit organization that is funded in part by the Associated Students and the Department of Political Science. CLIC encourages both students and community members to use our services and allow us to assist with any legal inquires.

CLIC interns research information for our clients through the use of all resources available. We pride ourselves in finding complete information that may be of use to our clients so that they may better understand their legal issues so they can make informed decisions on their own.

CLIC's paralegal interns provide clients strictly with legal information, since they are not licensed attorneys who can give advice. 

Housing Law



The Housing Law Project is a department at CLIC that provides legal information to California tenants and landlords on housing law related issues. This department is ran by two co-directors and at least six interns per semester.

Housing Law: Frequently Asked Questions



Are 3-day-notice, 30 day notice, and evictions all the same?

No, 3-day-notices and 30 day notices are notices to vacate, while an eviction is a legal document from the court also known as an unlawful detainer.

Can my landlord enter my rental unit whenever they want?

No, under CA Civil Code 1954 the landlord must give written 24 hour notice to enter the dwelling.

What are the basic responsibilities of my landlord to keep my rental unit habitable? Under CA Civil Code 1941.1 landlords have the responsibility to keep the rental unit fit for human occupation; this includes dead bolt locks effective weatherproofing, free from vermin or filth, electrical lighting, plumbing, and hot and cold running water.

How long does my landlord have to return my security deposit back?

Under CA Civil Code 1950.5 The landlord must do one of two things within three weeks after you move out; return all of your deposit or provide an itemized statement of deductions including receipts for work done and items purchased if the amount over \$125.
