 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Continental Food Company (Holdings) Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, "we are the "data controller". This means that "we" determines the purposes for which, and the manner in which, your Data is processed.

Data collected

5. We may collect the following Data, which includes personal Data, from you: a.

How we collect Data

- 6. We collect Data in the following ways:

Data that is given to us by you

7. "We" will collect your Data in a number of ways, for example:

- a. when you contact us through the Website, by telephone, post, e-mail or through any other means;

- c. when you make payments to us, through this Website or otherwise;
- d. when you elect to receive marketing communications from us;
- e. when you use our services;

Data that is received from third parties

8. "We" will receive Data about you from the following third parties: a. associated companies.

Data that is collected automatically

- 9. To the extent that you access the Website, we will collect your Data automatically, for example:

Our use of Data

Your rights
