  - f. Criminal history for all federal, state, and local convictions
  - g. Date the PTSR was generated
- 2. Be less than 30 days old.
- 3. Be made available to Allen Realty at no cost and directly from a consumer reporting agency or third-party website that is in the business of providing consumer reports.
- 4. Comply with all state and federal laws pertaining to the use and disclosure of consumer report information.
- 5. Contain a statement that since the PTSR was generated, there has not been a material change in the PTSR information, including your name, address, bankruptcy status, criminal history, or eviction history.

## **Residential Rental Application Fee**

If you do not have a PTSR, or your PTSR does not meet the above-listed requirements, Allen Realty will run a credit and background check and you will be required to pay Allen Realty's application fee of twenty-five dollars (\$25.00). The application fee is necessary to cover the credit and background report fees and associated labor costs. This fee is nonrefundable.
