# ROOSEVELT EWM (EURASIAN WATERMILFOIL) SURVEY RESULTS

RALALA hires Freshwater Scientific to do the milfoil survey of Roosevelt Lakes, which you will read about in the following report. Smokey Hollow, Leavitt and Lawrence lake are surveyed in Sept by PLM because they are smaller lakes and need the entire season for any milfoil to grow to a degree that they can be detected. In past surveys, no AIS plants have been found in these lakes.

The treatment for the identified sites on Roosevelt has been completed in August by PLM Lake and Land Management Corp. We are so fortunate that both the community leadership of Emily and Outing have funding available to help us pay PLM approximately \$20,000 for the treatment. The City of Emily has a program Emily Waters which has granted us \$4700 towards this invoice; Crooked Lake Township has the AIS committee which has granted us \$5000. Your generous donations to RALALA pay for the remaining balance of the invoice from PLM and for the survey costs from Freshwater Scientific. Your continued donations are very necessary.

You will see that the identified locations on Roosevelt are seemingly clustered near the Hwy 6 bridge. This year, your RALALA board voted to use a more expensive product ProcellarCOR which will hopefully eradicate the plants. It has also been decided to stop hand pulling the milfoil plant by members; we are seeing no success stopping reoccurring growth with this time consuming manual effort.

### SURVEY & ANALYSIS METHODS

#### **EWM DELINEATION SURVEY**

Freshwater Scientific Services. LLC completed a delineation survey for Eurasian watermilfoil (EWM) in Roosevelt Lake (#11-0043) on July 15, 2020. For this survey, we navigated a meandering search path over the vegetated portion of the lake while using a combination of surface observations, sonar readings, and rake tosses to locate and delineate areas of EWM growth. Visual and sonar assessments were conducted continuously, with subsequent rake tosses to assess EWM presence/abundance at sites where plants were not identifiable from the surface. We

recorded any locations with EWM using a hand-held Garmin GPS unit (GPSMAP78) and then documented water depth and EWM abundance (density rating; 1 to 3 scale as described below). Water clarity and overall visibility were excellent at the time of the survey, allowing us to conduct an intensive visual survey that was more likely to locate smaller patches of EWM growth than a rake survey alone.

Score	Visual	Rake
1	Light / Solitary plants	1-2 stems
2	Moderate / Dense patches	3 to 9 stems
3	Dense / Uniform matted EWM	10+ stems





# A FRIENDLY REMINDER, PERMITS REQUIRED

Greetings RALALA Members,

This is a friendly reminder from the City of Emily that land use permits are required for most exterior projects within city limits. All new and replacement structures including dwellings and accessory structures, all expansions to existing structures, fabric structures (hoop buildings), stairways, and dirt moving (grading)/shoreline alterations require a permit. Often times property owners (and sometimes contractors) assume Crow Wing County's land use ordinance applies to their property located in city limits which is not accurate. The city has it's own land use ordinance available online along with permit application forms at cityofemily.com. # CONTINUED REPORTS OF THE OTHER RALALA LAKES:

PLM completed the AIS surveys (checking for EWM/milfoil) for the RALALA group on Leavitt and Smokey Hollow and Lawrence lakes. Similar to years past, Leavitt seems to have a very healthy and mostly diverse native population and should continued to be searched annually. As for Smokey Hollow, we observed very little for submerged vegetation but floating leaf species and a handful of favorable pondweeds were observed. As discussed in years past, I don't believe Smokev Hollow is a lake that will have a milfoil problem and could be searched every other year.

PLM navigated the shoreline of Lawrence Lake and the channel between north Roosevelt and Lawrence. While navigating, two separate locations were observed to have (suspected) milfoil within the channel. One location West of the bridge near Roosevelt Lake and another East of the bridge, close to the opening to Lawrence Lake.

I believe it could be appropriate for MN DNR staff to hand pull the single plant for official identification. I also believe that MN DNR staff could search the general area closely for any additional EWM that could be covered by dense and abundant native milfoil.

### From the local DNR Nicole Kova, AIS specialist:

No adult Zebra Muscles were found during three different search efforts last year on Lawrence Lake. All lakeshore property owners should be vigilant to check their equipment as it is removed from our shorelines this fall.

Years ago, a big storm with straight line winds took down several trees on the point, forever changing the secret passage into a serene setting that was a quiet sanctuary for all to enjoy.

This land had been owned by Katy's father, Walt Gardner, since the 1930's. When Katy created the painting, the land was still in her family. My dad bought this portion of land from Katy in 1986 to prevent development of the bays. In 2017, this point and the land on the left in the painting, all part of Woods Bay, entered into the ownership of the MN DNR Aquatic Management Area.

Mary Jo and Don Dee, longtime RALALA members, bought this painting from Katy at the 1975 Emily Days art show. In 2017, because my family had owned the land, the Dees gave it to me when they permanently moved to Florida. This art has been well loved.


