<u>Instructions for Online dues payment and Direct Payments Services</u>

<u>Instructions for Filling out the .pdf Membership/Renewal Application</u>

Download to your computer the Membership Application form from the email or from www.hammondlandowners.org. It is not "fillable" when viewed in html, Windows, Google Docs or Google Drive .pdf viewer.

- 1. Open the Adobe Acrobat Reader program on your computer. (Free download at www.get.adobe.com/reader/)
- 2. At the top center of the screen select "**Fill & Sign**." (If it's not at that location, select "Tools" at the very top left and then choose "Fill & Sign."
- 3. Click on "Select a File" and double click on the .pdf document.
- 4. Click on "**Ab**" at the top of the reader and then on the first blank.
- 5. Select "X" or "✓". If you make a mistake, click the small trash can button or delete.
- 6. For the "**Signed**" blank, click at the top "**Sign Yourself**," select a signature and drag to the blank.
- 7. Finish filling in remaining blanks.
- 8. Select "Next" and "Save as read-only copy" and click on "Continue."
- 9. Choose where you want file to be saved and double click.
- 10. Click on "Save" to save it to your chosen location.
- 11. Send the saved form to hla@hammondlandowners.org as an attachment.
