If you are unable to find YOUR voter registration information, you may register to vote in advance of election day. The last day to register to vote in November is Tuesday, October 10, 2023.  
Register now so you can vote in the May Elections.
- 2. Read the Guide. Do your research. Learn about who is on the ballot.**  
We much prefer that you meet and speak with the candidates, however, we have provided links to existing Campaign Websites and Campaign Facebook pages.  
This should help you narrow down your choices.
- 3. Check the list of early voting locations below. (Election Day locations are at the back of this Guide.)**

- 4. This is a very short ballot unless you live in Rosenberg or Houston/Fort Bend. You are permitted to make a list of the issues you wish to support and carry it with you into the voting booth.**

## Voting By Mail

If you are a registered voter of Fort Bend County, you may be able to vote by mail if any of the following conditions would prevent you from going to the polls.

Expected absence from the County during both the early voting period **and** on Election Day.

(These ballots may only be mailed to an address outside of Fort Bend County.)

Disability

Expecting to give birth within 3 weeks before, or after, Election Day.

65 years of age or older

Confinement in jail and not convicted of a felony.



Prop. 1	“The constitutional amendment protecting the right to engage in farming, ranching, timber production, horticulture, and wildlife management.”
Prop. 2	“The constitutional amendment authorizing a local option exemption from ad valorem taxation by a county or municipality of all or part of the appraised value of real property used to operate a child-care facility.”
Prop. 3	“The constitutional amendment prohibiting the imposition of an individual wealth or net worth tax, including a tax on the difference between the assets and liabilities of an individual or family.”
Prop. 4	“The constitutional amendment to authorize the legislature to establish a temporary limit on the maximum appraised value of real property other than a residence homestead for ad valorem tax purposes; to increase the amount of the exemption from ad valorem taxation by a school district applicable to residence homesteads from \$40,000 to \$100,000; to adjust the amount of the limitation on school district ad valorem taxes imposed on the residence homesteads of the elderly or disabled to reflect increases in certain exemption amounts; to except certain appropriations to pay for ad valorem tax relief from the constitutional limitation on the rate of growth of appropriations; and to authorize the legislature to provide for a four-year term of office for a member of the board of directors of certain appraisal districts.”
Prop. 5	“The constitutional amendment relating to the Texas University Fund, which provides funding to certain institutions of higher education to achieve national prominence as major research universities and drive the state economy.”
Prop. 6	“The constitutional amendment creating the Texas water fund to assist in financing water projects in this state.”
Prop. 7	“The constitutional amendment providing for the creation of the Texas energy fund to support the construction, maintenance, modernization, and operation of electric generating facilities.”
Prop. 8	“The constitutional amendment creating the broadband infrastructure fund to expand high-speed broadband access and assist in the financing of connectivity projects.”
Prop. 9	“The constitutional amendment authorizing the 88th Legislature to provide a cost-of-living adjustment to certain annuitants of the Teacher Retirement System of Texas.”

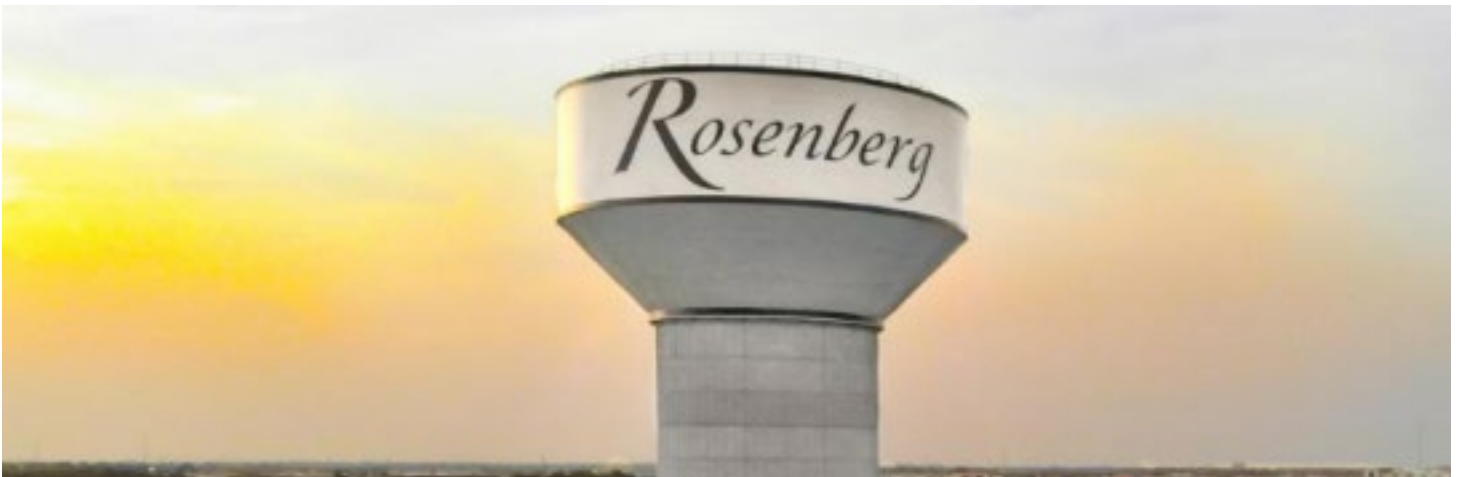

Must not have not been finally convicted of a felony from which the person has not been pardoned;

A person who has been finally convicted of a felony must include in the application proof that the person is eligible for public office; Must have resided continuously in Texas for 12 months immediately preceding the filing deadline.

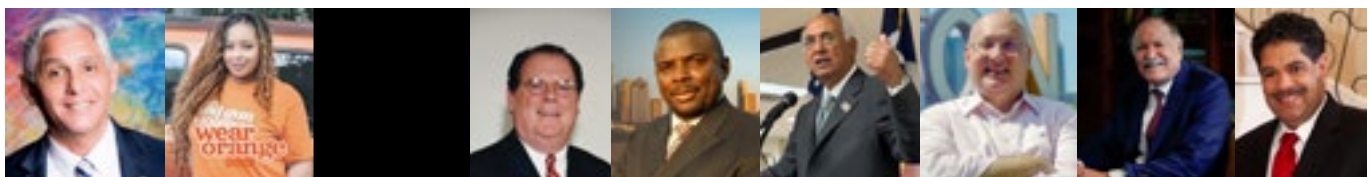
For candidates for Mayor, City Controller, or At-Large Council Member, Must have resided continuously in the City for 12 months immediately preceding election day - District Council Member, Must have resided continuously in the territory encompassed by the City Council District to be served for 12 months immediately preceding election day;

Must be registered to vote in the territory from which the office is elected on or before the date of the filing deadline.

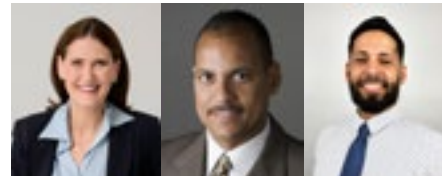

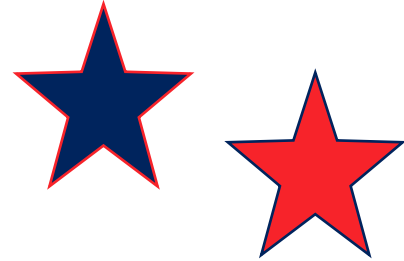

**The work our volunteers do guarantees that our elections run honestly and efficiently.**

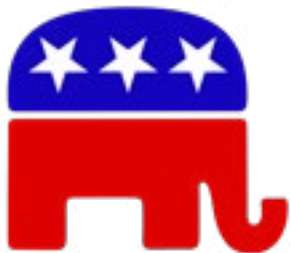
Election Workers work at the polls on election day and during early voting to ensure voters are able to exercise their rights in an honest and well-organized manner.
