COVID-19



Policy statement

Rotherfield Village Pre-School has a duty of care to both children and staff during the COVID-19 outbreak. The safety of those involved with the pre-school is always our priority. In order to keep our staff and pupils safe we adhere to the guidance set out by Government publications.

While the COVID-19 rates are decreasing, we are aware that a significant risk continues. Therefore, we still feel the need to ask our staff and the families that attend our setting to exercise personal responsibility, remain vigilant and be mindful of never knowingly compromising the health of others at pre-school or in the wider community. The Government has launched it's new 'Living with COVID Strategy' which means that the laws for COVID-19 testing have changed. The main changes are:

- Removal of the guidance for weekly asymptomatic testing
- Removal of the legal requirement to self-isolate following a positive COVID-19 test
- Removal of the legal requirement for those not fully vaccinated to self-isolate
- No longer asking fully vaccinated close contacts and those under 18 to self-isolate to test for 7 days
- Ending routine contact tracing
- Ending self-isolation support payments

Government guidance also continues to recommend that if you test positive you should stay at home/ avoid contact for at least five days and continue to isolate until you receive two negative LFD on two consecutive days.

In order to keep the staff, pupils, their families, and the extended community safe during COVID-19 please follow these procedures:


- 1. Wearing a face mask is optional for the approach to and from pre-school.
- 2. Please form a queue starting on the path that leads from the football HQ building.

- 3. A member of staff will greet you one at a time from within the gated area at the front of the preschool.
- 4. Staff and children wash their hands-on arrival. They will also wash hands before and after food, after using the toilet, if they sneeze or cough and when coming in from outside activities and at the end of the day before going home.
- 5. We have put a strict cleaning and hand washing regime in place, meaning toys, equipment and surfaces will be cleaned on a regular basis. Staff and children will follow the hand washing procedures.
- 6. Toys will be changed on a rota basis.
- 7. Windows and external door to the decking are open at points during the day to allow a flow of fresh air. Please ensure your child is appropriately dressed for this.
- 8. We have a C02 monitor to manage the room ventilation.
- 9. At the end of the day, please follow the same procedure as in the morning. A member of staff will bring the children out one at a time.
- 10. Parents of new start children will be able to stay with their child for a settling in session. Prospective parents will be able to visit the pre-school during opening hours.
- 11. We are now able to carry out educational trips/ visits.
- 12. If your child attends another setting, then you MUST make us aware of the name of the setting and how frequently your child attends.
- 13. We cannot guarantee that Rotherfield Village Pre-School will NOT be affected by a case of COVID
- 14.. We will be doing everything that we can to minimise the risks, but this will not prevent the virus being brought into the setting.

Symptoms of COVID-19:

- a high temperature
- a new continuous cough
- changes to your sense of smell or taste

If you develop symptoms of COVID-19 then it is still recommended that if you test positive you should stay at home/ avoid contact for at least five days and continue to isolate until you receive two negative LFD on two consecutive days.



Examples of when to end self-isolation if you have had COVID-19 symptoms or have received a positive COVID-19 test result

Staff and children attending pre-school are encouraged to test before attendance if they are displaying symptoms or if they are living in a household where someone has tested positive or if they have been in contact with someone that has tested positive within the last 7 days.

If you do not qualify as fully vaccinated for travel to England, you must take a COVID-19 test before you travel to England from abroad. Please see the guidance link below:
