



1. Pushing for Equal Pay for Equal Work

How have we fared on these three issues?

Equal Pay: Women make 79 cents to every dollar a man makes. We gained a whole penny since 2014. I guess that's progress, but we still have a long way to go. 21 more cents actually.

"Be brave enough to start a conversation that matters." That was my goal for the 2014-2016 Administration as your Second Vice President. I wrote in the June 2014 Clubwoman

Domestic Violence: In 2015 the Post & Courier newspaper in Charleston published an award winning series of articles called "Till Death Do Us Part", exposing the issue of domestic violence in South Carolina. By the summer of 2015, our state legislature passed, and our governor signed, a new domestic violence law which increased the punishments for abusers. We also heard today from our Attorney General Alan Wilson about the recent convictions under the state's new human trafficking laws. I think that is a lot of progress!

Second Vice President Women in Politics: Women hold only 13.5% of the seats in our state legislature. I think that is the lowest percentage in the country. But we do have a female governor and a female

running for President. Not to mention our own clubwoman Trudie Heemsoth was recently elected to serve as Fort Mill city councilwoman.

I stand here today encouraged that women are making a difference in South Carolina. I have read your reports, and I know our clubwomen are tirelessly working to improve our communities, our state and our world. As my time serving as your Second Vice President comes to an end, I hope you will remember these words from Prince: "Compassion is an action word with no boundaries."

#### Year End Tasks for the Treasurer!

IRS Reporting: The 990-N or E-Postcard filing is due every year by the 15th day of the 5th month after the close of your tax year (5 ½ months after the close of your club's fiscal year). If you are not eligible to file the 990-N, you will need to file the IRS Form 990, 990-EZ. or 990-PF. YOU MUST FILE SOMETHING!

Secretary of State Reporting: The Registration Statement for a Charitable Organization, The Application For Registration Exemption, and the Annual Financial Report for a Charitable Organization are all due on an annual basis 4 1/2 months after the close your club's fiscal year. YOU MUST EITHER REGISTER OR APPLY FOR AN EXEMPTION FROM REGISTRA-TION – EACH YEAR. If your club files the 990-N or E-Postcard – you must complete and file the Secretary of State's Annual Financial Report Form with either your Registration Statement for a Charitable Organization or Application for Registration Exemption.

Fund Raisers: If your club must file the Secretary of State's Annual Financial Report Form, you will need to keep detailed financial records of ALL fundraisers; such as: Gross Receipts, Charitable Contributions, Cash Prizes, Noncash Prizes, Rent/Facility Expenses, Food and Beverage Costs, and other Direct Expenses.

Raffle Registration: As of March 5, 2015, under the South Carolina Code of Laws §33-57-120(A), only qualified nonprofit organizations are eligible to conduct raffles. Generally,

in order to conduct a raffle, a nonprofit organization must file an annual raffle registration form with the S.C. Secretary of State Division of Public Charities. The annual raffle registration form is available on the Secretary of State's website at www.sos.sc.gov, under Forms and Fees. Each Club Treasurer should read the information on this new law to determine if their club must complete the raffle registration.

- The raffle registration includes a \$50.00 filing fee.
- 2. Registered organizations are required to file an annual raffle financial report with the Division of Public Charities 4 ½ months after the end of their fiscal year (includes itemized receipts/expenditures for each "non-exempt" raffle.) This form is also available on the Secretary of State's website.





# Judy Bilyeu GFWC-SC Woman of Distinction

When Judy Duncan Bilyeu came to Aiken in 1973, she was hired as the first Executive Director of a full-day developmental program for children who had developmental disabilities. During her two and one half years there, the center became a model for other S.C. counties for opening similar centers, and was a training ground for students from The Medical College of Georgia and The University of South Carolina Aiken. The Center received an award from the S.C. Asso. For Retarded Citizens for its quality program.

Just prior to the birth of her first child in 1976, Judy resigned from Child Development Center and became a member of Aiken Junior Woman's Club. During her years in AJWC, she organized a training session to provide baby sitters for children with disabili-





A major effort at this time was serving as a founding board member and vice president of Tri Development Center. TDC combined the Child Development Center (she once directed) and Adult Development Center to later become a large multifaceted center for people with Intellectual Challenges.

When her youngest child entered kindergarten, Judy went to work as a part-time week-day Pre-School Teacher at St. John's United Methodist Church Pre-School, where she stayed for 12 years. While there she was able to identify, for early intervention, several students who had hearing or perceptional weakness whose early treatment enabled them to be highly successful as they grew older.

When her youngest son's speech did not develop normally, and following extensive testing, her son, Jeff, was diagnosed with above average intelligence but with weakness in auditory and visual perception. This caused him to learn differently. His efforts to learn as the other children were difficult for him. He was learning to hate school. Local schools were unable to address Jeff's problems clinically. In a joint-effort with Sandra Mashburn, a reading expert from Augusta, Ga., and many wonderful people in Aiken, The Mashburn School, a private non-profit school for children with disabilities similar to Jeff's, was opened in a room in St. John's UMC in 1986. Judy served as Board Chair, doing the necessary paper work to attain tax exempt status. Later, the board asked her to be the school's part-time administrator which she did for three years. The school continued to operate for 15 years. Jeff mainstreamed into middle school on-grade level (advanced in Math) in 6th grade. He is now 38 years old, and has gone on to achieve success in his professional and personal life.

In 1996, Judy completed a MEd degree in Counseling from the University of South Carolina and became the counselor at Willison-Elko Middle School in Barnwell County. She stayed for twelve years. While there, she conducted small group and individual counseling, play therapy, set up programs in Character Education, Career Awareness, and Sexual Abstinence. Some years she also taught Talented and Gifted Classes. She was selected Teacher of the Year at the end of her first year. Who knew that one decision would lead to tonight? Finally and most importantly, I am forever grateful to my dear club, the Woman's Club of the Midlands, for their encouragement as I have travelled the path of leadership in our state. From the time I joined you in 2008 to now, you have been so kind to me as I have gone from District President to now State President. I look forward to being with you all each month because it gives me a "home base" to touch and to sit back and laugh and share. You are all so very special to me and I am so happy you are here tonight. I cannot say thank you enough to all of our members across the state that give countless hours serving their community. SC is better because of you caring so deeply.

During my term as your president, I want to show my appreciation for your dedication by providing you with an opportunity to have some extra fun with your girlfriends. So mark your calendar now for December 4th because we are taking a bus trip to visit our national headquarters in Washington, D.C. My Fundraising Chairman, Vickie Lovett and Dolly Mc-Dermott of the North Myrtle Beach Woman's Club are working on the details and will have it for you at summer session. This will be a trip you won't want to miss!

As state president, the greatest honor is being able to bring awareness to issues that are near and dear to my heart. Issues that I am most passionate about...issues that I hope you too will become passionate about over the next two years. First, "What Color is Your Cancer?....Mine is Pink and Teal" I have asked Sylvia Ayers to chair this part of my special project. Thank you Sylvia!

As a 13 year breast cancer survivor, I know what it feels like to receive the call saying you have cancer. I received that call at age 39. When I hung up with the nurse, I walked across the street and handed Genna (who was only 4 months old) to my neighbor, went home, called Gary and my Mama and cried. My dear friends rallied around me, as did my woman's club. I went on a yearlong journey to rid my body of the cancer and to this day have had no recurrence. Five months into my own journey, my mother was diagnosed with peritoneal cancer, which is treated just like ovarian cancer...hence the teal. So I not only know what it feels like to be a cancer survivor, I also know what it feels like to be a caretaker of a family member with cancer and what it feels like to lose that family member. So I truly do understand...What I would like for you to do as a club is to support whichever cancer means the most to you. You can do this by walking in Relay for Life, hosting a fashion show to raise awareness, or have a speaker to talk to your specific cancer type...just show your passion to help end this disease so that sometime in the near future no one will ever have to hear the words you have cancer....to help you with this, Wade Bonner, Chief Operating Officer at South Carolina Oncology Associates, and husband of Sara Bonner of the Jr. Woman's Club of Lake Murray, will be at our Summer Session in July to outline how they can help us and in addition, they have offered to host our winter session in January at their facility here in Columbia.

I would like you to take time to remember those lost to this disease, but to also celebrate our survivors...and we have many....they are each a hero to me! So when I asked....What Color Is Your Cancer....this is what I learned! (show video)

The second area I am very passionate about is "Dyslexia Awareness....more specifically Genna's story". Gail Elfert of the St. Andrews Woman's Club will chair this project for me. Thank you Gail!

I would like you to take time to remember those lost to this disease, but to also celebrate our survivors...and we have many....they are each a hero to me! So when I asked....What Color Is Your Cancer....this is what I learned! (show video)

The second area I am very passionate about is "Dyslexia Awareness....more specifically Genna's story". Gail Elfert of the St. Andrews Woman's Club will chair this project for me. Thank you Gail!

Genna was in first grade when she was diagnosed with a specific learning disability – Dyslexia. Dyslexia is a language based learning disability that affects 1 in 5 students and occurs in people of all backgrounds and intellectual levels. People with dyslexia are often very bright and gifted in areas such as art, computer science, drama, music and sports. In addition, dyslexia runs in families...as it does in our family. Gary, Ashlan and Genna all have varying levels of dyslexia so left/right and hot/cold are not always the same in our house and we really don't worry about what day it is...we just count how many sunshine's until a certain event.

Children with Dyslexia are just like their peers – except that they learn different. Thankfully, South Carolina is blessed with specialized schools who help the children prepare for a bright future. Genna began attending one of those schools here in Columbia this year after...Sandhills School where accomplishments are celebrated and I know she will be fully prepared for college and a great future.

To help you better understand what a child with dyslexia deals with every day, Mrs. Ann Vickers, Head Principle of Sandhills, will present a mini day in the life of a dyslexic child at our summer session.

Sandhills offers a Summer Skills Camp to all children where they can receive specialized language instruction and multi-sensory math classes. In addition they offer accredited teacher training during the summer. Teachers can go through this training and take what they learn back to their home district and help teach the children how they learn. What I would like is for us to raise awareness about dyslexia and to help with that I would like to share with you "the faces of dyslexia"....

Finally, when I first met Anne Redlus, who came to us as a past state president of GFWC New Jersey, she shared with me how she picked her state project. She told me how, in addition to what she wanted to do, the state clubwomen voted and chose a state project they would like to focus their efforts on. From that conversation, came the final part of my project called "Your State...Your Project". In the fall, you were asked to go online and choose one of our partners to focus on as a state and once the votes were tallied, you had chosen the GFWC Signature Project...Domestic Violence Awareness! Sue Burgess of North Myrtle Beach Woman's Club will serve as chairman for this portion of my state project. Thank you Sue!

Much has been done over the years to focus on Domestic Violence, but that effort really accelerated over Caroline's administration. Our presence at the State House has increased through this effort and is one that we want to continue. Domestic Violence should never be and we must continue to help those in need. Please continue the great work you have done with the shelters in your area and reaching out and helping these women and children in need. Know that your one act of kindness can change their life. We must continue our fight to end Domestic Violence...

I am excited to share with you my logo...a turtle in pink and teal..."Sharing our Passion...One Step at a Time"....now you are probably wondering why a turtle? Well, for several reasons as it relates to my projects. When I was going through my treatments, it was a slow and steady pace...one step at a time...one chemo, one radiation, one surgery at a time. Gary bought me a bracelet and the first charm we put on it was the turtle. The turtle is a symbol of longevity, endurance and persistence against incredible odds...it became a symbol of my life. With Dyslexia, the children take one step at a time to learn how to deal with the challenges they face each and every day...and the survivors of domestic violence take one step at a time in to their new life.

In just a moment, Genna and Anna Grace are going to come forward to sing a song that really represents the challenges of each portion of my project, but first I want to thank you all, the members of the General Federation of Women's Clubs of South Carolina for allowing me this wonderful opportunity to lead and to serve each of you over the next two years...I am so excited to see what you will do as you continue "Living the Volunteer Spirit." I hope you enjoy the rest of your evening and thank you again for being here and celebrating with me and all of your new officers!



I am so looking forward to the next 2 years! I am excited to be serving with Janet Prince, Carrie Zimmerman and the rest of our executive committee. Over the next two years I will be focusing on the "Hopeful" campaign. This is to bring education about and advocacy for homeless youth or "unaccompanied youth." It is estimated that 1 in 8 youth are homeless. In South Carolina there are only two shelters that offer help, Sea Haven in Myrtle Beach and Palmetto Place in Columbia.

## New Form 990-N Submission Website Now Open

Form 990-N electronic submissions should now be made through IRS.gov instead of Urban Institute's website. For the filing link and more information on how to file, visit the Form 990-N Web page.

Form 990-N, Electronic Notice (e-Postcard) for Tax-Exempt Organizations Not Required to File Form 990 or Form 990EZ, is used by small, tax-exempt organizations for annual reporting and can only be submitted electronically.

## **Registration Now Required**

Form 990-N filers will be required to complete a short, one-time registration before submitting their electronic form to IRS.gov.

All organizations are required to register at IRS.gov prior to filing Form 990-N. You won't be asked to register again the next time you file.

Form 990-N must be completed and filed electronically. There is no paper form.

Form 990-N filers may choose to file a complete Form 990 or Form 990-EZ instead.

## Miss Jolene: A Legacy Story By: Laura Bryant Palmer

I joined the Spartanburg Junior Women's Club in the fall of 1991 after being instructed to do so by my mother. She had been a member of the GFWC-Jubilee Club for many years and insisted that I join. Not following her instructions was something I was unaccustomed to doing, so, at the age of 22, I became a clubwoman. I went to all of the meetings, learning what it was to be member. I was in graduate school and single, living a very different life from that of many of the young mothers in the club. My mother encouraged me to keep going and said that I would love it, just as she did. She was right. A trip to Puerto Rico for Southern Region Conference in the fall of 1992 gave me my first taste of what the organization I had joined was all about. My mother introduced me to ladies from across the Southern Region that she had been friends with for years. They were now my friends.

She called me one Saturday morning in 1999 and said that she would like for me to run for State Junior Director. At that time she was President-elect for the state of South Carolina. I told her that I could not. I was working full time as a teacher, was in graduate school (again), had a husband and young son, and did not have enough money to do the travelling the office required. She repeated that she wanted me to run, giving me detailed explanations of how all of these other things would work out. She wanted us to have the experience of being State President and State Junior Director at the same time. I was elected the Junior Director of South Carolina at the next state convention. Yet again, she was right. It was a wonderful experience. During the 2000-2002 administration, my mother and I travelled across the state, the region, and the country together. The memories that I have from those two years are numerous and precious. I can see her the night we were installed in the state, standing there with my 6-year-old son. I will never forget the Board of Directors meeting in Washington. We enjoyed seeing our friends from around the country, visiting our beautiful national head-quarters for a reception, and taking in the sites around the Capital. We flew home on 9/10/01. I will always remember the image of her at the International Convention, in her Operation Smile dress, walking up to receive an award on behalf of the state. Operation Smile was her special project during those two years.

After our time as state officers, we continued to travel together. She would call to tell me she had sent our registration for this or that meeting and that I owed her so much for my meals. She would tell me she and I would be staying with this such and such from her club at whatever hotel. These other ladies became my other mothers. I have memories of purse auctions, long drives, and meetings at the bar after the official meetings were recessed. A rainstorm at Disney World, gambling in Puerto Rico, raffle tickets, dancing, chicken, more chicken, tired feet, and snoring are just a few of the countless memories I have of our travels and conventions together.

At the state convention in the spring of 2014, she installed the officers for the new administration. She smiled at me and was very proud to pin the Northern District President's pin on my dress. I have a great picture of us from that night, her colorful glasses are perched right there on her nose. My mother won the Woman of Distinction Award from our state federation in 2012. I was just as proud of her that night. At the Saturday night banquet in April 2015, she was honored by her club by being nominated for the Order of the Jasmine. I accepted that award on her behalf. The next morning at the annual memorial service, District Presidents lit a candle for those members in their respective districts who had passed on since the last convention. My mother's name, Jolene Willard Bryant, was called. I lit her candle. It was our last convention.

His father was an F-16 fighter pilot in the US Air Force which required many relocations growing up. Due to the frequency of his father being re-stationed every two to three years, Wade lived in South Carolina four different times before completing high school, so he considers himself a native. Wade spent the first three years of high school in Sumter, South Carolina and the last year of high school in Gaffney, South Carolina due to his father's retirement from the service. Wade has called Columbia home since 1998 when he enrolled at the University of South Carolina as an undergraduate. Friends, graduate school, church, and South Carolina Oncology Associates (SCOA) have kept him in Columbia ever since. Wade has been employed at SCOA for 14 years and currently serves as the Chief Operating Officer.

Wade is married to Sara Bonner (JWC of Lake Murray) and they have two children; Avery (7) and Reese (5). They live in Irmo and are active members at First Baptist Church of Columbia where Wade serves as a deacon, high school small group leader, and Sunday school teacher.

GFWC-SC President's Special Project Dyslexia Awareness Gail Elfert – Chairman

One in five students has some degree of Dyslexia....1 in 100 teachers knows the signs. We need to raise awareness of Dyslexia and share the early signs so these students can be identified and then taught the way they learn. Sandhills School in Columbia is an Orton Gillingham College Prep School. Sandhills offers a four week Summer Skills Camp program for children to receive specialized language instruction. They also offer a training for teachers from across the state to learn how to teach to these children. My goal is for us to raise scholarship money to assist children to be able to attend the summer camp as well as teachers. If your school district identifies a teacher that would benefit from this training and cannot afford the total tuition, your club could raise money for that teacher. By doing this your money donated comes back into your community through the skills that teacher will be learning.





Anne Vickers, Head of Sandhills School, has been in education for 40 years. Her love and passion for students with dyslexia has led her on an exciting career path. After receiving her Bachelor of Science in Education and Masters in Special Education from The College of Charleston she completed the strenuous requirements of an additional 250 hours of course work and 600 hours of Orton-Gillngham supervised practicum experience to become a Fellow with the Academy of Orton-Gillingham Practitioners and Educators (AOGPE) in 1995.

As a Fellow, Sandhills School has allowed the school to remain as one of thirteen prestigious schools accredited by AOGPE and one of eighteen training centers accredited by AOGPE.

As a training center, Vickers has been able to train over 200 other teachers and members of the community through the Orton-Gillingham Associate Level 40 hour course, giving countless children the gift of reading. In addition to this, Vickers has led numerous workshops, including "A Walk in Your Child's Shoes," for Sandhills parents and the community about Dyslexia, ADD & ADHD, and other learning differences.

Vickers has worked in a variety of environments in the public and private school systems since 1977 as a Language Development teacher, Public School resource teacher, Learning Resource teachers and Assistant Director for Curriculum and Instruction prior to coming to Sandhills School in Columbia, SC in 2001 as the Head of School. She was recognized in 1997 at Charlotte Latin School, while a Learning Resource Teacher, as the Teacher of the Year, receiving the esteemed Spratt Teaching Award.

Prior to joining Sandhills School, Vickers served on The Carolinas Branch Orton Dyslexia Society as a board member and as vice-president, The Orton Dyslexia Institute as a board member and as secretary, Learning Disabilities Association, and the NC Orton Dyslexia Society board. As Head of School, Vickers has served on the SC International Dyslexia Association and The Nurturing Center Boards. She has also been a member of the International Dyslexia Association.

Vickers' legacy to date at Sandhills School has been the implementation of a Southern Association of Colleges and Schools (SACS) accredited high school and the Spring 2013 completion of The Faulds Building, which now houses the growing high school. This is a vital part of Sandhills community outreach, because until recently, there was not a specialized high school for those with learning differences. Vickers is proud of the students that have graduated from the high school who are all now happily attending the four year college of their choice.
