

But also thank you to all members who continue to 'Invest in our Planet' through daily actions and habits of recycling, reusing, composting, energy conservation, smart shopping and more. Each day we have the opportunity to make a positive impact on our environment in numerous ways — many are easy and free and have been detailed in previous articles. Readers are encouraged to continue to review the GFWC manual for the comprehensive guidelines and resources of this CSP when considering program/project ideas or for self-education.

And the results of the Pull Tab service project are in! The "Queen of Pull Tabs" is Becky Robbins of Sand River Woman's Club with a whopping 18 lbs. 2 oz collected. Other top contributions were appointed to the "Royal Court" and are: Peggy Grillot of Lake Murray-Irmo WC with 5+ lbs.; Lexington WC with 12lbs; St Andrew's WC with 2lbs. 12 oz. and Upstate WC with 2 lbs. In addition, there were several other un-labeled containers donated which came to 25 lbs. Therefore, the grand total of pull tabs to be donated to a Ronald McDonald House is 65 pounds. That's a whole lot of pull tabs considering it takes about 100 tabs to equal 1 ounce!

Clubs Who Have Clubhouses in South Carolina

Did you know that Historic Preservation in a part of GFWC and is a goal of Civic Engagement and Outreach? It is and Kristin Fields and I, at the encouragement of Nancy Greenberg, GFWC Chairman of Civic Engagement and Outreach, decided to make a list of all the clubs in our state that preserve and have a meeting place of their own which is their clubhouse.

First there is our State Headquarters, the Sims-Stackhouse Mansion, at 1511 Laurel Street in Columbia, South Carolina. "This stately classic style home was constructed by James Sims before 1853" and survived Sherman's burning of Columbia. T.B. Stackhouse purchased it in 1909 and GFWC-SC has used it as its headquarters since 1953. Plan to come to the annual Christmas Stocking Extravaganza, join the 1511 Society, or even rent it for an event at a special member's price.

The Woman's Club of Cayce was organized in the spring of 1937, and in 1939 the Guignard family donated the land on which the clubhouse now stands. "The log cabin building was erected in 1940 with 34 members authorizing the execution of the \$1,000.00 for note for materials." Labor was provided by the WPA (Works Progress Administration), a Government Program to provide work for millions following the Great Depression. This building has been in continuous use since that time. You may have attended a state event there.

The GFWC Winnsboro Woman's Club was federated in 1925. This club is located at 35 Vanderhorst Street in Winnsboro. The City of Winnsboro provided a building for the clubhouse. Like all our clubs, this Club has done many wonderful things to improve life and a sense of community in their town.

The Belvedere Woman's Club was federated in 1955. They began looking for a piece of property. In 1977 the Club paid \$3,000 for a lot at 104 Elizabeth Avenue and on April 26, 1978 the Belvedere Woman's Club Community Building opened. Beth Broome, whose mother-in-law was very active in founding the Club and the clubhouse, is a member and helps take care of the building with her husband. The Club meets monthly.

The Woman's Club of Rock Hill purchased their clubhouse in 1971. It was built by W.R. Armstrong in 1921 when he was Mayor of Rock Hill. Armstrong sold it to the Mauldin family who owned the Coca Cola Company in Rock Hill. The clubhouse is of Spanish and American Colonial style with restored gardens. Ann Bruce Faircloth, the Mauldin's daughter, sold the house to the Club. In 2011, the Club purchased an adjoining house and lot which had been built in 1939 to complete the original historic property of that time period.

Clubhouses make it easy for the Club to have celebrations, events, and meetings but require extra work to maintain. These houses provide a good source of income and community recognition for the Club when the clubhouses can be rented for events.

If there is a clubhouse in your history that was missed, please let Ellen Mayes know.



SARA STRINGFELLOW WOMAN OF DISTINCTION Woman's Club of Rock Hill

Not many clubs in South Carolina, or anywhere else for that matter, have a 99 year-old member. Woman's Club of Rock Hill was blessed to have had a very active 99 year-old member, Sara James Carter Stringfellow.

Sara was born April 8, 1922 in Chester, South Carolina. She graduated from Winthrop College with a degree in Education and later completed a Master's Degree in Library Science. There are many in Rock Hill who will still today tell you their favorite teacher, and the one they credit for their success in life, is Sara Stringfellow.

While earning her first degree, in 1944 Sara completed a special curriculum and was selected to be a Code Girl, a secret group of American women who served as code breakers in Washington,



Sara was very active in her community. She was a charter member of Junta Literary Society. She was a longtime member and volunteer of her church, Oakland Avenue Presbyterian. Sara was a member of the Daughter's of the American Revolution and the Fleur-De-Lis Garden Club of Rock Hill. She was an avid bridge player and member of four different bridge clubs. Sara was the mother of four children and grandmother to six children, who adored her.

Sara encouraged and inspired her club from her first year in 1988 when she created one of the club's largest and long-lasting fundraisers, The Bridal Fair. As chairman of the Education Department, Sara developed programs to help underprivileged students in the poorest schools in the District. She was active in the STAR Program, which tutored students from a low-income school for over 28 years. Sara encouraged her club to provide books for the tutors. She also ensured students were given opportunities like going to camp and to concerts. Sara encouraged student writers by advocating with her Club to solicit entries from local students to submit to the GFWC-SC Youth Writing Contest. When her Education and Libraries CSP had worked 4 years and finally obtained a Little Free Library, at age 98 Sara offered to paint it and provided her granddaughter to decorate it. They spent hours in the hot sun painting and decorating the library. Sara was unaware that her club's Education and Libraries had already voted to name the little library Sara Stringfellow's Book Nook. With Covid closing the local libraries, this Little Free Library gave many hundreds of books away in just its first few months.

Sara faced adversity. She had severe heart problems when she was in her late 40's. Her grandson was killed several years ago in a traffic accident and, creating something positive from the tragedy, The John Corey Stringfellow Scholarship Memorial was established in his memory. Sara was extremely proud that through it, many are able to further their education.

Sara's friends knew an article about her was planned to appear in GFWC-SC's Clubwoman in September 2021, and had hoped to keep it a surprise to her until she opened the magazine. Learning, however, that Sara was not expected to live through the night, a copy of the article was sent to her family and was read to her on the night she died. Sara passed away peacefully on September 3, 2021 at her home, surrounded by her family.

Woman's Club of Rock hill may no longer have their 99 year-old Sara cruising Rock Hill in her convertible, but they do have 34 years of memories to treasure of an exemplary legacy of service, and of a great lady and fellow Clubwoman. There are few such as Sara, who lived such a long and giving and caring life.

Project Lifesaver is a 501 (C)(3) community based, public safety, non-profit organization that provides law enforcement, fire/rescue, and caregivers with a program designed to protect, and when necessary, quickly locate individuals with cognitive disorders who are prone to the life threatening behavior of wandering. The organization was founded in 1999 in Chesapeake, Virginia. The necessity of this program was determined through the correlation between cognitive conditions and the act of wandering. With the dramatic increase of cognitive conditions since the inception of the organization, the program has grown from a localized program to a program recognized internationally as a proven and effective method of **"bringing loved ones home."**

Project Lifesaver was the first to apply such locating techniques to aid in the search and rescue of individuals, and is the most widely used and proven most effective program in the nation that is specifically designed to protect the "At Risk" populations in our communities. The program was structured in a way that strategically combined state of the art locating technologies, innovative search and rescue methods, and community policing courses that educated first responders about cognitive conditions. The search times for certified Project Lifesaver agencies have been reduced from hours, potentially days, down to minutes. Recovery times for Project Lifesaver agencies average 30 minutes, which is 95% less time than standard operations without Project Lifesaver.

HOW DOES THE PROJECT LIFESAVER PROGRAM WORK?



The Project Lifesaver Program is run at a municipality level by public safety agencies. When an agency decides to implement the program, Project Lifesaver International will equip them with the necessary technologies and provide training to those involved. The training includes the use of the equipment, the implementation of the strategic methods specifically designed for the program, and also community policing courses that provide a basic understanding of cognitive conditions to better comprehend the behaviors of an individual with said condition. Also included during training is the use of the PLS Database, which is a useful resource provided to member agencies at no cost. The method relies on proven radio technology and specially trained search and rescue teams. Citizens enrolled in Project Lifesaver wear a small transmitter on the wrist or ankle that emits an individualized frequency signal. If an enrolled client goes missing, the caregiver notifies their local Project Lifesaver agency, and a trained emergency team responds to the wanderer's area. The first responders will then use the client's individualized frequency to locate the position of the individual.
