



Butterfly for First Place, Cocoon for Second Place and Caterpillar for Third Place. To be judged by the President's Special Project Chair, report due March 15.

Best Practice - Comparative Statement

A Comparative Statement should be prepared periodically to keep your Club Members and Executive Committee/Board aware of how well your club is staying within the budget. The statement should show each account in the budget, the budgeted amount for each account, and the actual disbursements against each account as of the report date. Here' a simple example of a Comparative Statement.






