SERVICE AGREEMENT

Terms and Conditions of Agreement:

This is the contractual part; please review carefully.

PLEASE NOTE: The utmost care will be given in watching both your pet(s) and your home. However, due to the extreme unpredictability of animals we cannot accept responsibility for any mishaps of any extraordinary or unusual nature (i.e. biting, furniture damage, accidental death, etc.) or any complications in administering medications to an animal. Nor can we be liable for injury, disappearance, death or fines of pet(s) with access to the outdoors.

The parties herein agree as follows:

Tuck 'em In is authorized to perform care and services as outlined on this contract.

- I. The initial term of this agreement shall be from ______ through ______ . In the event of early return home, client must notify **Tuck 'em In** promptly to avoid being charged for unnecessary visit(s).
- 2. Client agrees to the fees for service as provided at time of consultation. Payment for service is due in full at time of signing of this agreement. Should a cancellation of service occur prior to 48 hours of first visit, the client will receive a refund of fees paid (less a \$12.50 inconvenience fee). Cancellations occurring less than 48 hours before first visit will forfeit 50% of fees paid or \$12.50, whichever is more. Other fees for additional services or circumstances may apply. Any additional visits made or services performed shall be paid for at the agreed contract rate.
- 3. **Tuck 'em In** is also authorized to seek veterinary care with release from all liabilities related to transportation, treatment and expense. Should specified veterinarian be unavailable,
- 4. Tuck 'em In is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Tuck 'em In for expenses incurred, plus any additional fee for attending to this need or any expenses incurred for any other home/food/supplies needed.
- 5. In the event of inclement weather or natural disaster. **Tuck 'em In** is entrusted to use best judgment in caring for pet(s) and home. **Tuck 'em In** will be held harmless for consequences related to such decisions.
- 6. Tuck 'em In agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against Tuck 'em In except those arising from negligence or willful misconduct on the part of Tuck 'em In.
- 7. Client understands this contract also serves as an invoice and takes full responsibility for payment in full upon signing. A handling fee of \$35 will be charged on all return checks. In the event it is necessary to initiate collection proceedings on an account, Client will be responsible for all attorney's fees and costs of collection.
- 8. In the event of personal emergency or illness of Debra Oligny, Client authorizes Debra Oligny to arrange for another qualified, insured, bonded employee of **Tuck 'em In Sitter Service** to fulfill responsibilities as set forth in this contract. Client will be notified in such a case.

- 9. All pets are to be current on all vaccinations. Should an employee of **Tuck 'em In** be bitten or otherwise exposed to any disease or ailment received from Client's pet(s) which has not been properly and currently vaccinated, it will be the Client's responsibility to pay all costs and damages incurred by victim.
- 10. Tuck 'em In reserves the right to terminate this contract at any time before or during its term. If Tuck 'em In, in its sole discretion, determines that Client's pet poses a danger to health or safety of an employee, if concerns prohibit Tuck 'em In from caring for pet, Client authorizes pet to be placed in a kennel, with all charges (including transportation costs) to be charged to Client.
- 11. Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting **Tuck 'em In** to accept telephone reservations for service and enter premises without additional signed contracts or written approval.
