# COMMANDER BRUCE A. TAGER, USN

# **COMMANDER JOHN J. FLYNN, USN**

A native of Providence, Rhode Island, Commander John J. FLYNN, USN, graduated from Providence College and was commissioned an Ensign upon completion of Officer Candidate School in 1956. His first assignment was the USS CHAMBERS (DER-391) where he served as Communications/Electronics Officer.
